THE COMMISSION OF ENQUIRY INTO SEDCO AND THE COMMERCIAL BOARD NOTICE, 1992

(Under Section 3)

In exercise of the powers conferred by Section 3 of the Commission of Enquiry Act, 1963, I Barnabas C.F. Mhlongo, Minister for Commerce and Industry, hereby issue the following Notice

Citation.

1. This Notice may be cited as the Commission of Enquiry into Sedco and the Commercial Board Notice, 1992.

Establishment.

2. (1) There is hereby established a Commission to be known as the Commission of Enquiry into Sedco and the Commercial Board (hereinafter referred to as the "the Commission ").

(2) The Commission shall be composed of the following members -

(a)	Mr. Douglas Lukhele	- Chairman
(a)	MI. Douglas Lukileie	- Chairman

- (b) Mr. Phillip D. Dlamini Member
- (c) Mr. Musa P. Ndzimandze Member
- (d) Mr. Sandile Pato Secretary

Functions of the Commission.

3. (1) The commission shall examine and enquire into the establishment, operations and functions of Sedco and the Commercial Board and shall, without prejudice to the generality of the foregoing, enquire particularly into -

- (a) whether the objects for which Sedco and the Commercial Board were established have been met;
- (b) the terms and conditions of service of employees of Sedco and the Commercial Board;
- (c) the policy or practice regarding the recruitment of staff and any practice regarding the disciplining of staff of Sedco and the Commercial Board;
- (d) whether the present operations of Sedco and the Commercial Board do enable the organisations to meet the aspirations of small businesses and the Swazis at large;
- (e) any irregularities or unlawful acts pertaining to the acquisition of property, advantage or any other consideration by the employees of Sedco and the Commercial Board;
- (f) the collection, control and application by Sedco and the Commercial Board of funds and the maintenance of proper records in respect of such funds;
- (g) the issuing of authority to construct, alter, occupy or demolish buildings by Sedco and the Commercial Board;

- the carrying out of feasibility studies and recommendations by Sedco and the Commercial Board of projects undertaken by them.
- (ii) the award of tenders for such projects;
- (iii) the monitoring and extension of the projects and the payment thereof;
- (2) The commission shall further -
 - (a) examine and enquire into any other matter relating to the activities which are the subject matter of this enquiry as it may consider relevant;
 - (b) make any recommendations it finds appropriate based on its findings;
 - (c) recommend appropriate action, whether civil, criminal or disciplinary against any employees involved in such irregularities or unlawful acts; and
 - (d) make recommendations as to the future viability of Sedco and the Commercial Board.

Enquiry Venue.

4. The enquiry shall be held at Houses of Parliament or at such other place and at such times as the Commission may determine.

Enquiry in Camera

5. Except where the Minister for Commerce and Industry otherwise directs, the enquiry shall be held in camera, and the Commission shall take such steps as to preserve the secrecy of the proceedings and recommendations.

Interim Report.

6. The Commission may submit an interim report or recommendation to the Minister in any matter which in the opinion of the Commission require urgent action.

Duration of the Enquiry.

7. The Commission shall commence its function on 4th January, 1993, and shall submit its report to the Minister for Commerce and Industry by 12th February, 1993 or on such later date as the Minister may permit in writing
