***Quorum.***

4. The quorum of the Sub-Committee shall be four members including the Chairman.

***Functions of the Sub-Committee.***

5. (1) The functions of the Sub-Committee shall include the following:

- (a) to consult all relevant stakeholders in the Manzini Satellite bus rank impasse;
- (b) to identify the issues leading to the impasse;
- (c) to propose short, medium and long term options to address the stalemate;
- (d) to formulate its own rules of procedure for the effective implementation of its mandate; and
- (e) to submit its report within a period of twelve (12) days.

(2) The Sub-Committee may establish, co-opt or enter into an agency agreement with any person or institution for the proper execution of its functions and mandate.

(3) In the execution of its functions the Sub-Committee shall have the power to administer oaths and to subpoena any person to give evidence.

***Duration.***

6. (1) The Sub-Committee shall operate for a period of twelve (12) days, commencing on the 4<sup>th</sup> day of June 2012.

(2) The Sub-Committee shall present its report to the Minister after completion of the exercise; and

(3) Notwithstanding subsection (1) and (2), the Minister may, by Notice published in the Gazette, extend the period of operation of the Sub-Committee or the date by which it shall present its report.

***Enquiry in camera.***

7. (1) The Sub-Committee shall carry out its functions at such a place as the Chairman may determine.

(2) The work of the Sub-Committee shall be held in camera.

***Allowances.***

8. Members of the Sub-Committee shall be paid such travelling and sitting allowances in terms of the relevant and applicable finance circular or any other appropriate instrument.

APPOINTMENT OF THE NATIONAL STEERING

***Citation and Commencement.***

***Establishment of the Commission of Enquiry.***
