THE IMPOSITION OF LEVY FOR SAVINGS AND CREDIT  
COOPERATIVE SOCIETIES NOTICE, 2014  
(Under Section 21)

In exercise of the powers conferred by Section 21 of the Financial Services Regulatory Authority Act, 2010, the Authority issues the following Notice-

*Citation and Commencement*

1. (1) This Notice may be cited as the Imposition of Levy for Savings and Credit Cooperative Societies Notice, 2014.

(2) This Notice shall come into force on the date of publication.

*Imposition of levy*

2. (1) A Savings and Credit Cooperative Society shall pay a levy of zero point one per centum (0.1 %) of all deposits and savings held as indicated in the last audited accounts for the year ended March, 2013/2014.

(2) The levy shall become due by the 1<sup>st</sup> September, 2014.
