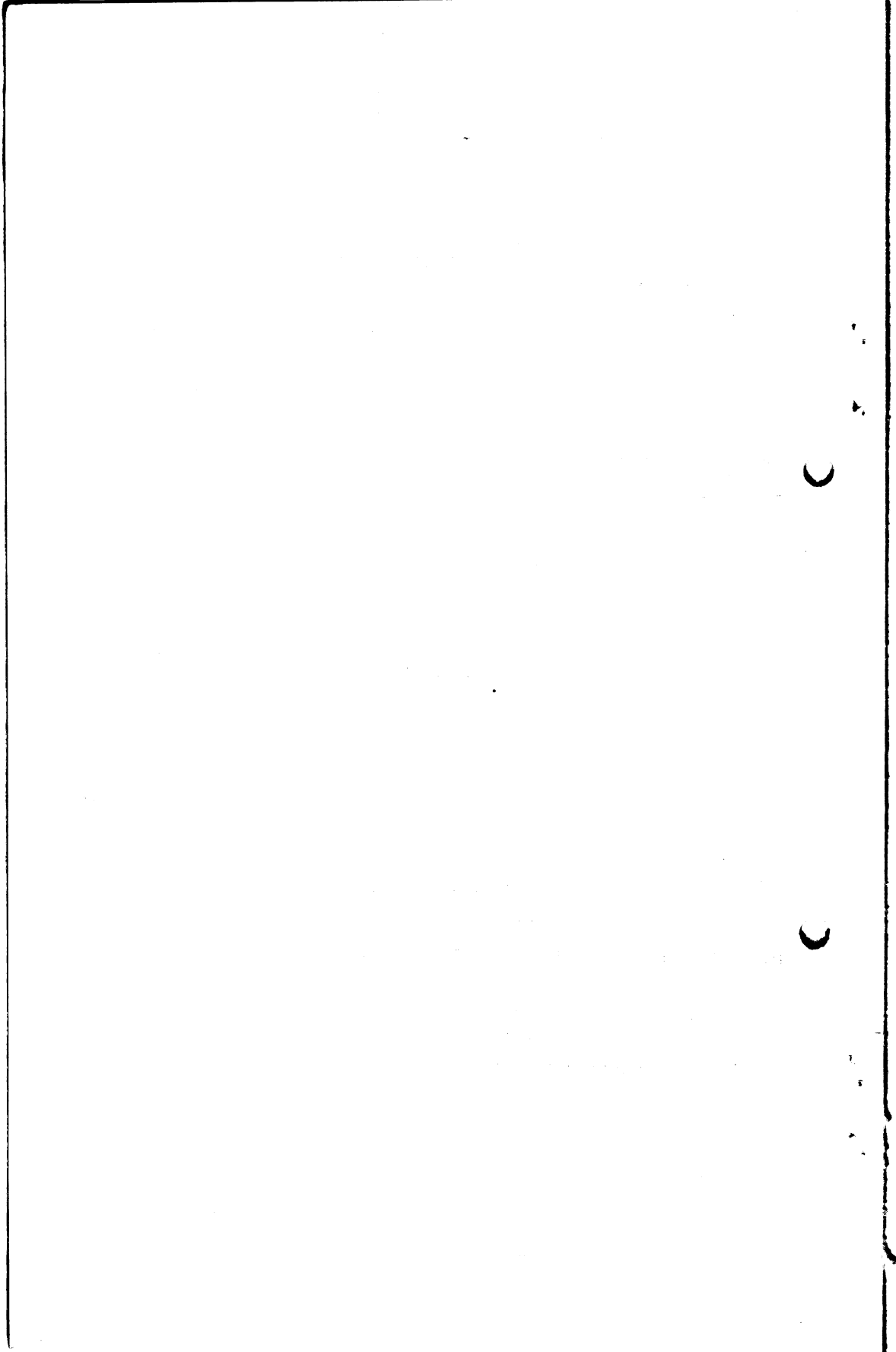

In exercise of the powers conferred upon him by section 106 of the Post Office Act, 1962, the Minister of Works, Power and Communications is pleased to make the following Regulations —

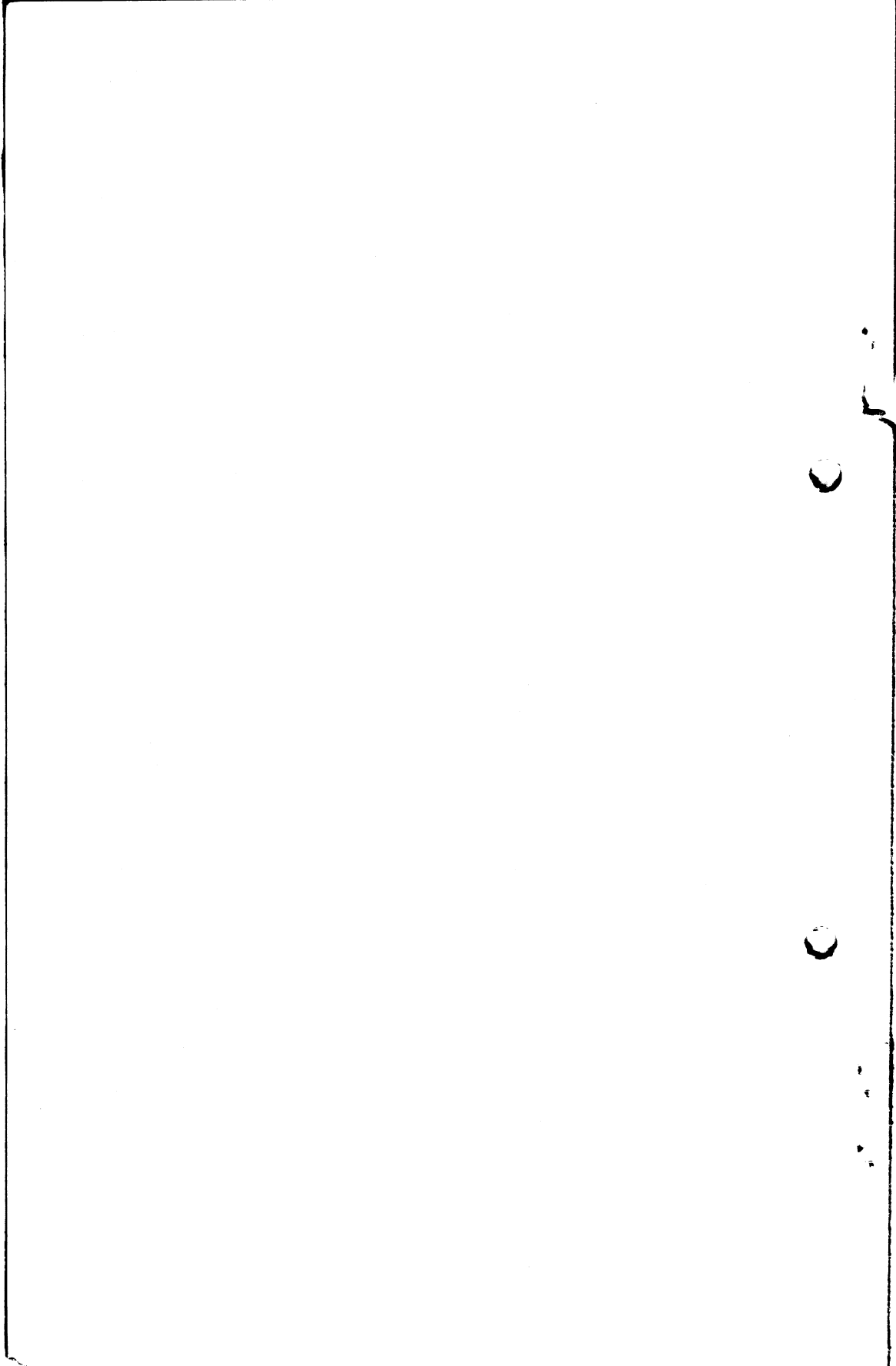
