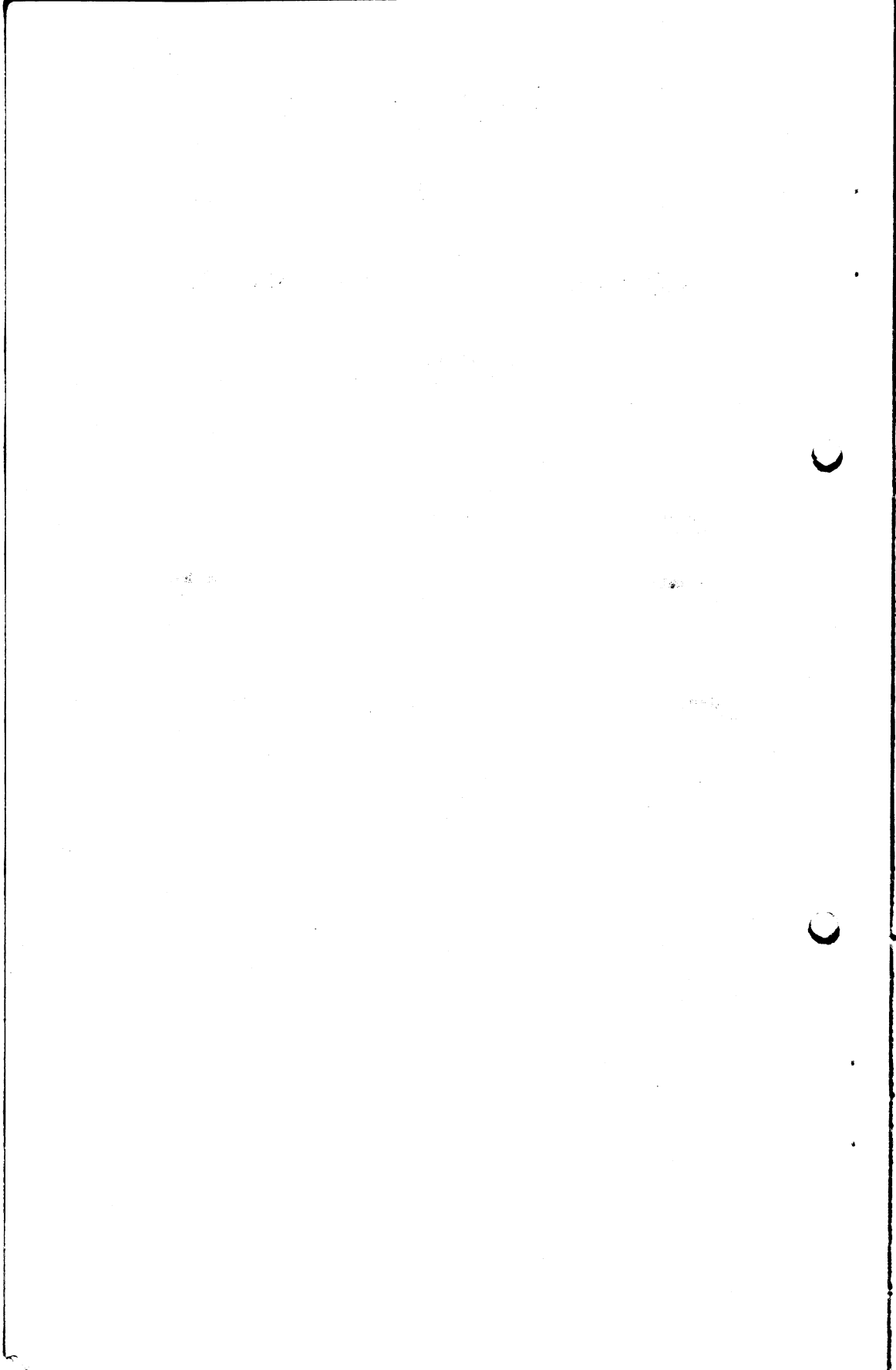

THE CONTROL OF CEREALS ACT NO. 28 OF 1959

THE CONTROL OF PRICES OF MAIZE AND MAIZE MEAL NOTICE, 1979

(Under Section 4(1))

(Date of commencement: 4th May, 1979)

In exercise of the powers conferred on him by the above-mentioned Act, the Honourable the Minister for Agriculture has been pleased to fix the price for which maize products shall be sold in Swaziland.

Citation.

1. This Notice may be cited as the Control of Prices of Maize and Maize Meal Notice, 1979.

2. Regulation No. 2 of Legal Notice No. 65 of 1976 is hereby amended by replacing the definition "bag of maize" with the following — "bag of maize" means a unit of 70 kgs net weight.

3. Regulation No. 3 of Legal Notice No. 65 of 1976 is hereby amended by replacing "per 90 kg bag" by "per 70 kg bag" in paragraph (1) thereof.

4. Regulation No. 2 of Legal Notice No. 35 of 1978 is hereby amended by replacing the amount "E8.09" by "E7.43" in paragraph (1) thereof.

Amendment of Regulation No. 3 of Legal Notice No. 65 of 1976.

5. Regulation No. 3 of Legal Notice No. 65 of 1976 as amended by Legal Notice No. 36 of 1978, is hereby further amended by replacing the amount "64 cents" by "70 cents" for bag allowance in paragraph (1) thereof.
