1. This Notice may, be cited as the Amendment of Certificate of Approval Notice, 1979 and shall come into force on the 17th. August 1979.

*Amendment of certificate of approval.*

2. (1) The Certificate of approval in respect of the type of measuring instrument described in the Schedule is amended to the extent specified in sub-paragraph (2) of this paragraph.

(2) On and after the coming into force of this Notice, the certificate of approval referred to in the Schedule shall not be valid in respect of any measuring instrument of the type described in the Schedule if, immediately before that date, the instrument is not in use for trade in Swaziland.

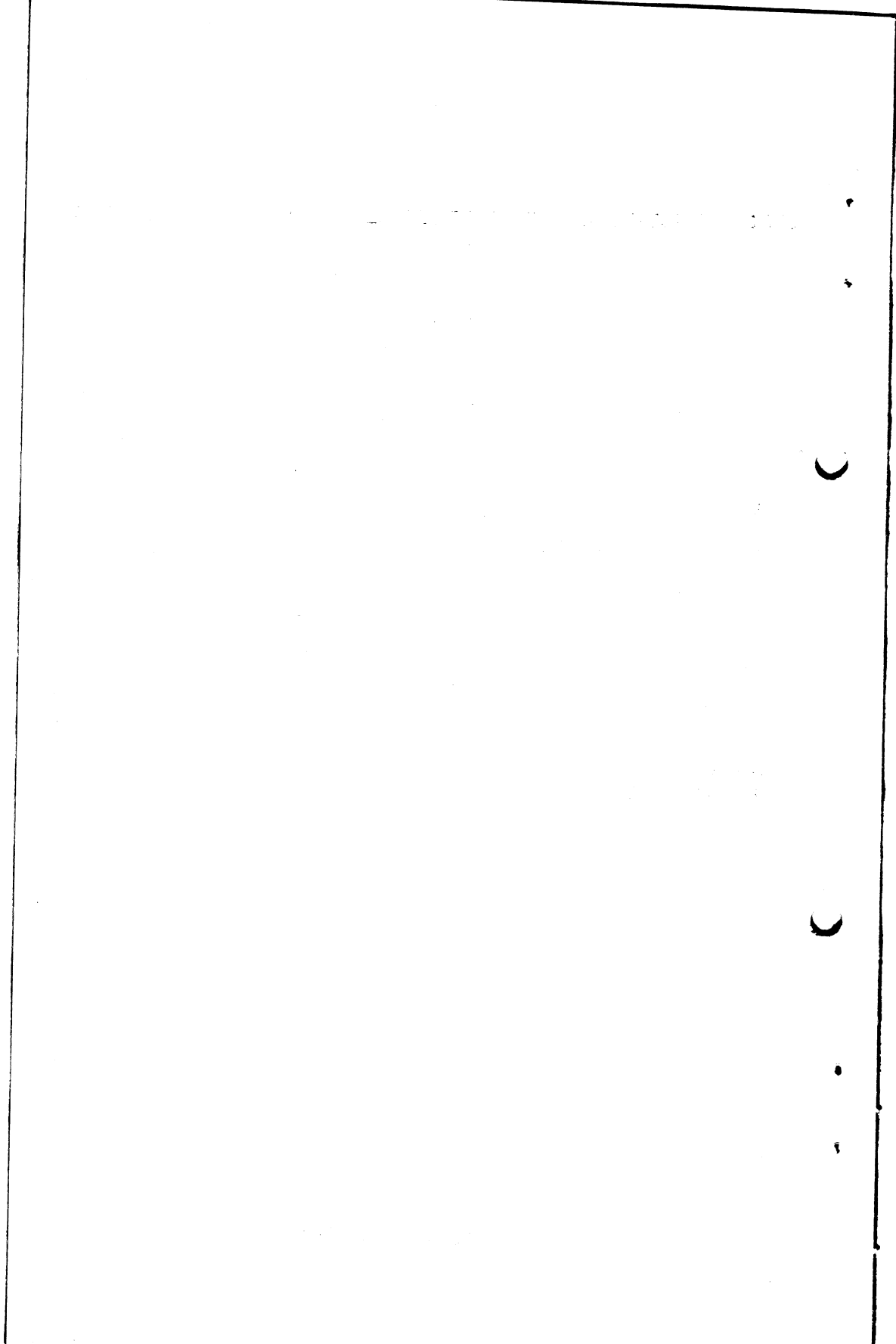
