THE THIRD EDUCATION DEVELOPMENT LOAN ACT, 1979

(Act No. 11 of 1979)

AN ACT

entitled

An Act to authorise the raising of a loan from the International Bank for Reconstruction and Development for the purpose of financing the Education Development Project.

(Date of Commencement: 21st December 1979)

ENACTED by the King and the Parliament of Swaziland –

Short title

1. This Act may be cited as the Third Education Development Loan Act, 1979.

Interpretation

2. In this Act, unless the context otherwise requires –
“Agreement” means the Agreement referred to in section 3 and includes any documents relevant thereto;
“loan” means the loan raised by the Minister in terms of section 3;
“Minister” means the Minister for Finance.

Authority to raise loan

3. The Minister is hereby authorised to enter into an Agreement with the International Bank for Reconstruction and Development for the purpose of raising a loan not exceeding an amount equivalent to ten million one hundred thousand United States dollars (US \$10,100,000), (Approximately E8,400,000) upon the terms and conditions set out in this Act and upon such other terms and conditions as he may consider appropriate.

Loan charges and repayments

4. (1) The loan shall carry on interest rate of 7.95% per annum on the principal amount of the loan withdrawn and outstanding from time to time plus a commitment charge at the rate of 3/4 of 1% per annum on the principal amount of the loan not withdrawn from time to time.
- (2) The loan shall be repayable over a period of fourteen years including a grace period of four years commencing from the date of the Agreement.

Charging of loan

5. The loan shall be charged upon the Consolidated Fund and the assets of the Government of Swaziland.

Application of loan

6. The proceeds of the loan shall be used for promoting the educational policy and objectives of the Government of Swaziland so as to improve –
 - (a) the access, efficiency and relevance of primary and secondary education;
and
 - (b) the management capacity of civil servants.

THE POST OFFICE ACT, 1962

(Act No. 60 of 1962)

THE POSTAL (AMENDMENT) (NO. 3) REGULATIONS, 1979

(Under section 105)

In exercise of the powers conferred by section 105 of the Post Office Act 1962, the Minister for Works, Power and Communications hereby makes the following Regulations:-

Citation

1. These Regulations may be cited as the Postal (Amendment) (No. 3) Regulations, 1979 and shall come into force on the 1st January, 1980.

Interpretation

2. In these regulations:
"the principal regulations" means the Postal Regulations, 1962.

Amendment of Schedule B. Part III 'A' – Surface Mail

3. Part III (A) of Schedule B of the principal regulations is amended by replacing the various rates of postage for parcels to the countries listed with the new rates as set out in the First Schedule hereto.

Amendment of Schedule B Part III 'B' – Airmail

4. Part III (B) of Schedule B to the principal regulations is amended by replacing the various rates of postage for parcels to the countries listed with the new rates as set out in the Second Schedule hereto.
