THE THEFT AND KINDRED OFFENCES BY BUBLIC OFFICERS (AMENDMENT) ACT, 1981

(Act No. 5 of 1981)



I ASSENT SOBHUZA II King of Swaziland 2nd April, 1981

AN ACT entitled

An Act to amend the Theft and Kindred Offences by Public Officers Order, 1975.

(Date of Commencement: 24th April, 1981)

ENACTED by the King and the Parliament of Swaziland.

Short title.

1. This Act may be cited as the Theft and Kindred Offences by Public Officers (Amendment) Act, 1981 and shall be read as one with the Theft and Kindred Offences by Public Officers Order, 1975, hereinafter referred to as "the Order".

Amendment of section 2.

- Section 2 of the Order is amended
 - (a) by deleting the definition "public money";
 - (b) by replacing the definition "responsible officer" with the following
 - "responsible officer" means a person who is empowered to suspend a public officer and includes a body of persons having such power;
 - (c) in the definition "public property" by replacing the words "public money" with the word "money";
 - (d) by inserting the following definitions in their appropriate alphabetical order— "parastatal body" means any body, whether corporate or unincorporate in which the Government, the Ngwenyama in trust for the Swazi Nation or the Swazi National Council holds any financial or monetary interest and includes any other body in which such parastatal body holds a financial or monetary interest:

"public officer" means the holder of any public office and includes the holder of any office in the Royal Swaziland Police Force, the Umbutfo Swaziland Defence Force, the Prison Service and any employee holding office in any Statutory Corporation or parastatal body;

"statutory corporation" means any body, whether corporate or unincorporate, established or under any law;

(e) by replacing the definition "theft" with the following —

"theft", in addition to its ordinary meaning, includes any offence involving fraud, forgery, false pretences and the receiving of property with knowledge that it has been stolen.

Replacement of section 3.

3. Section 3 of the Order is replaced with the following section —

"Suspension of Public Officer and Prohibition from dealing with Assets

- 3. (1) Notwithstanding any other law or any terms or conditions of employment
 - (a) where a responsible officer has reasonable grounds to believe that a public officer has committed theft in respect of any public property, he may, after consultation with the Director of Public Prosecutions, suspend such public officer from the exercise of the powers and functions of his office with a view to instituting disciplinary or criminal proceedings against him:

Provided that where it appears to the responsible officer that the alleged theft has resulted or is likely to result in the loss of public property, the responsible officer shall immediately suspend the Officer and, not later than seven days after such suspension and without prejudice to any action taken or to be taken by the Police in respect of the alleged theft, refer the matter to the Director of Public Prosecutions;

- (b) a person who has been suspended in accordance with paragraph (a) shall
 - (i) by virtue of such suspension alone and without further action or proceedings, become disqualified from disposing of, pledging, mortgaging or otherwise hypothecating or alienating the assets held by him (whether alone or with any other person) or any interest therein and the responsible officer shall inform the Registrar-General and the Registrar of Deeds accordingly; and
 - (ii) with effect from the date of his suspension, but subject to subsection (2), cease to receive any further salary, wages or other emoluments relating to his office.
- (2) Without prejudice to any action which may be taken under any other law or under the terms or conditions of service governing the salary, wages or other emoluments of a public officer who is under suspension, the provisions of sub-section (1)(b) (ii) shall cease to apply to an officer three months after the date of his suspension unless within the said period —

- (a) such officer has appeared in court on a charge of theft; or
- (b) through his own default, such officer has failed to appear in court after being so required by a public prosecutor or after being summoned or by evading to be summoned in connection with the alleged theft.
- (3) Any person who, while under suspension and contrary to sub-section (1)(b)
 - (a) disposes of, pledges, mortgages or otherwise hypothecates or alienates any assets held by him or any interest therein; or
 - (b) receives any further salary, wages, or other emoluments in respect of the office from which he was suspended;

shall be guilty of an offence and liable on conviction to a fine of one thousand emalangeni or twelve months imprisonment or both."

Replacement of section 4.

- 4. Section 4 of the Order is replaced with the following section
 - "Penalty for theft by public officer.
 - 4. A person convicted of theft under this Order shall be liable to a minimum sentence of six months imprisonment in the case of a first conviction or a minimum sentence of twelve months in the case of a second or subsequent conviction, without the option of a fine, and no such sentence or part thereof shall be suspended:

Provided that the Court may impose a lesser penalty of imprisonment or a fine —

- (a) if the person so convicted establishes the existence of any extenuating circumstances in connection with the commission by him of such offence; or
- (b) if, having regard to the age of the person convicted or the value of the public property in respect of which the offence was committed, the Court is of the opinion that in the interest of justice such lesser penalty is more appropriate."

THE DAIRY ACT, 1968

(Act No. 28 of 1968)

THE PRICES OF POWDERED MILK AND ALLIED PRODUCTS REGULATIONS, 1981

(Under section 24)

In exercise of the powers conferred on him by section 24 of the Dairy Act, 1968 and on the recommendation of the Swaziland Dairy Board, the Minister for Agriculture and Cooperatives hereby makes the following Regulations:-

Citation and Commencement.

1. These Regulations may be cited as the Prices of Powdered Milk and Allied Products Regulations, 1981 and shall come into force on the 23rd April, 1981.

Maximum Wholesale and Retail Selling Prices.

2. The maximum wholesale and retail selling prices of powdered milk and allied products in Swaziland shall be as set out in the Schedule to this Notice.

Revocation of Legal Notice No. 14 of 1981.

3. The Prices of Powdered Milk and Allied Products Regulations 1981 which came into force on 27th February, 1981 are hereby revoked.
