KING'S DECREE NO. 1 OF 1981

THE ESTABLISHMENTS OF THE PARLIAMENT OF SWAZILAND
ORDER, 1981

(Order No. 23 of 1978)

THE KING'S PROCLAMATION (AMENDMENT) DECREE, 1981

(Under section 80)

In exercise of the powers conferred upon me by section 80 of the Establishment of the Parliament of Swaziland Order, 1978, I, SOBHUZA II, KING OF SWAZILAND, hereby make the following Decree:-

Short title and commencement.

1. This Decree may be cited as the King's Proclamation (Amendment) Decree, 1981, shall be read as one with the King's Proclamation to the Nation of the 12th April, 1973 and shall be deemed to have come into operation on the 19th January, 1979.

Amendment of King's Proclamation to the Nation.

2. The King's Proclamation to the Nation of the 12th April, 1973 is amended by adding the following paragraph after paragraph 13 of the Decree:-

"14. The following matters shall continue to be regulated by Swazi law and custom:—

- (a) the office of Nggwenyama;
- (b) the office of Ndlovukazi (the Queen Mother);
- (c) the authorization of a person to perform the functions of Regent for the purposes of section 30 of the repealed Constitution;
- (d) the appointment, revocation of appointment and suspension of Chiefs;
- (e) the composition of the Swazi National Council, the appointment and revocation of members of the Council and the procedure of the Council;
- (f) the Ncwala ceremony;
- (g) the Libutfo (regimental) system."

(Order No. 6 of 1974)

THE KING SOBHUZA II DIAMOND JUBILEE COMMEMORATIVE COIN
ISSUE

In exercise of the powers vested in me by the Central Bank of Swaziland Order, 1974, I hereby issue the following Notice:-

Citation.

1. This Notice may be cited as the King Sobhuza II Diamond Jubilee Coin Issue Notice, 1981.

Interpretation.

2. In this Notice unless the context otherwise requires —

“commemorative coins” or “commemorative issue” means the King Sobhuza II Diamond Jubilee commemorative coins issued in terms of this Notice.

Commemorative issue.

3. The coins to be issued by the Central Bank of Swaziland shall be a special commemorative issue honouring His Majesty, King Sobhuza II, and to mark the Diamond Jubilee of His Majesty's accession to the throne.

Denomination, material, dimensions, weights and quantities.

4. The commemorative issue shall consist of coins of the following denominations, materials, dimensions, weights and quantities.

Shape of commemorative coins.

5. The four Commemorative Coins shall be round and with milled edges.

Design and inscription.

6. The Commemorative Coins shall bear the following designs and inscriptions:-

- (i) on the obverse side of the 250 (Two hundred and fifty) Emalangeni, the 25 (twenty five) Emalangeni, and both the 2 (two) Emalangeni silver and cupro-nickel coins shall be engraved and inscribed:
 - (a) in the centre, the image of His Majesty King Sobhuza II, with the year 1921 on the left and the year 1981 on the right;
 - (b) along the upper edge above the image of His Majesty and following the curve of the coin the words in one line in the English Language "Diamond Jubilee";
 - (c) along the lower edge below the image of His Majesty and following the curve of the coin the words in one line in the English Language "His Majesty King Sobhuza II".
- (ii) On the reverse side of the Two Hundred and Fifty Emalangeni (E250) gold coin —
 - (a) in the centre the image of an elephant;
 - (b) above the image of the elephant and to the left of centre the number "250" in Arabic numerals;
 - (c) along the upper and right hand edge and following the curve of the coin the word "Emalangeni" and the year "1981" in Arabic numerals in one line and separated by a dash;
 - (d) along the lower left hand edge and lower edge and following the curve of the coin the word "Swaziland".
- (iii) On the reverse side of the Twenty Five Emalangeni (E25) silver coin —
 - (a) in the centre the image of a Purple Crested Lourie;
 - (b) on the left side of the image of the Purple Crested Lourie the number "25" in Arabic numerals;
 - (c) along the upper edge above the image of the Purple Crested Lourie and following the curve of the coin the word "Emalangeni" and the year "1981" in Arabic numerals in one line and separated by a dash;
 - (d) along the lower left-hand edge and lower edge and following the curve of the coin the word "Swaziland".
- (iv) On the reverse side of the Two Emalangeni (E2) silver coin —
 - (a) in the centre the image of two specimens of the Calla Lily (*Zantedeschia Rehmannii*) with leaves;
 - (b) on the left side above centre the number "2" in Arabic numerals;
 - (c) along the upper edge and above the image of the said Calla Lilies and following the curve of the coin the word "Emalangeni" and the year "1981" in Arabic numerals in one line and separated by a dash;
 - (d) along the lower edge and following the curve of the coin the word "Swaziland".

- (v) On the reverse side of the Two Emalangeni (E2) cupronickel coin —
- (a) in the centre the image of two specimens of the Calla Lily (*Zantedeschia Rehmannii*) with leaves;
 - (b) on the left side above centre the number "2" in Arabic numerals;
 - (c) along the upper edge and above the image of the said Calla Lilies and following the curve of the coin the word "Emalangeni" and the year "1981" in Arabic numerals in one line and separated by a dash;
 - (d) along the lower edge and following the curve of the coin the word "Swaziland".
