Citation.

1. This Notice may be cited as the Assumption of Regency by the Ndlovukazi Notice, 1982 and shall be deemed to have come into force on the 21st August, 1982.

Assumption of Regency by Ndlovukazi.

2. Consequent upon the death of HIS MAJESTY KING SOBHUZA II on the 21st August, 1982, the functions and responsibilities of King shall be performed by INDLOVUKAZI DZELIWE with effect from that date.
