Title and Commencement.

1. This Notice may be cited as the Law Reform and Development Commission (Amendment) Notice, 1982, shall be read as one with the Law Reform and Development Commission Notice, 1981 and shall be deemed to have come into force on the 1st January, 1982.

Amendment of General Notice No. 106 of 1981.

2. The Law Reform and Development Commission Notice, 1981 is amended by adding the following paragraph after paragraph 3 —

"Remuneration, Fees and Allowance, etc.

4. The members and Officers of the Commission shall be paid such remuneration, fees and allowances as the King may determine and such expenditure shall be paid from public funds."
