# THE KING'S PROCLAMATION TO THE NATION OF 1973

# RE-AFFIRMATION OF THE APPOINTMENT OF MEMBERS

## OF THE LIQUOO

WHEREAS I, NTOMBI, am the Ndlovukezi and Regent of the Kingdom of Swaziland, having been duly appointed and installed as such under Swazi law and custom, AND WHEREAS, His Majesty King Sobhuza II, the late King of the Kingdom of Swaziland, by virtue of the King's Proclamation to the Nation of 1973, assumed supreme legislative, executive and judicial powers over the Kingdom of Swaziland.

AND WHEREAS Such supreme legislative, executive and judicial powers now by virtue of Swazi law and custom and by virtue of Section 30 (1) of the Repealed Constitution of the Kingdom of Swaziland now, subject to Swazi law and custom, vest in me.

NOW THEREFORE, I, NTOMBI, Ndlovukazi and Regent of the Kingdom of Swaziland hereby in the due exercise of my aforesaid powers hereby re-affirm the appointment of, and as far as may be necessary, re-appoint, the following persons to be members of the Liqoqo with retrospective effect as from 24th August, 1982.

# THE DELEGATION OF THE REGENT'S POWERS NOTICE, 1983 (Under Section 69)

In exercise of the powers vested in me, I, NTOMBI, NDLOVUKAZI AND REGENT of the Kingdom of Swaziland, hereby issue the following Notice:

### Citation

 This Notice may be cited as the Regent's Delegation of Powers Notice, 1983 and shall be deemed to have come into force on the 9th August, 1983.

Delegation of Powers of Appointment, etc.

2. Where in any law the power to appoint any person to hold or act in any public office, to exercise disciplinary control over persons holding or acting in such office or to remove such person from office is vested in the King or, in the absence of a King, the Regent, such power may be exercised by the Authorised Person after consultation with the Regent.
