THE STOCK DISEASES (RABIES) REGULATIONS, 1984

(Under section 3)

In exercise of the powers conferred by the Animal Diseases Act, 1965 the Minister for Agriculture and Co-operatives hereby makes the following Regulations—

1. These Regulations may be cited as the Stock Diseases (Rabies) Regulations, 1984 and shall be deemed to have come into force on the 8th December, 1983.

*Declaration of Rabies Guard Areas.*

2. The dipping tanks and other areas specified in the Schedule hereto are hereby declared to be Rabies Guard Areas.

*Isolation and confinement of dogs in the Rabies Guard Areas.*

3. Every owner of a dog in any of the Guard Areas shall isolate and confine it so as to prevent it from escaping from such Guard Area.

*Destruction of dogs in Rabies Guard Areas.*

4. A Government Veterinary Officer may destroy a dog in any of the Rabies Guard Areas which, in his opinion has not been confined so as to prevent it from escaping from such Guard Area.

*Offence and Penalty.*

5. An owner of a dog in any of the Guard Areas who contravenes or fails to comply with regulation 3 shall be guilty of an offence and liable to a fine of E300.00 or imprisonment for a period of six months.

- (c) the total discharge into the Usuthu River of black liquor solids shall be based upon the river flow as follows—

- (g) where change in odour or taste occurs in the river, the Company shall collect samples from the lower sampling point, determine the presence of phenols and submit the results at half-yearly interval to the Water Resources Branch for evaluation;
- (h) during the winter low flow period of the Usuthu River and while the factory is in operation, the Company shall take samples from the river at points specified in the South African National Institute of Water Research (Report No. 9—C.S.I.R.) and send them to the Water Resources Branch once a year.
