THE PUBLIC HEALTH REGULATIONS, 1935

THE PUBLIC HEALTH (PROHIBITION OF IMPORTATION) NOTICE, 1984

(Under regulation 1 *bis*)

In exercise of the powers conferred by regulation 1 *bis* of the Public Health Regulations, 1935 the Minister for Health hereby issues the following Notice —

*Citation.*

1. This Notice may be cited as the Public Health (Prohibition of Importation) Notice, 1984 and shall come into force on the 17th February, 1984.

*Prohibition of importation.*

2. The importation from the Republic of South Africa or the Peoples Republic of Mozambique into Swaziland of any vegetables or fruits in an unprocessed state or the conveyance of such vegetables or fruits within Swaziland without a written permit granted by the Minister for Health is hereby prohibited.

*Revocation of Legal Notice No. 13 of 1981.*

3. The Public Health (Prohibition of Importation) Notice, 1981 is hereby revoked.
