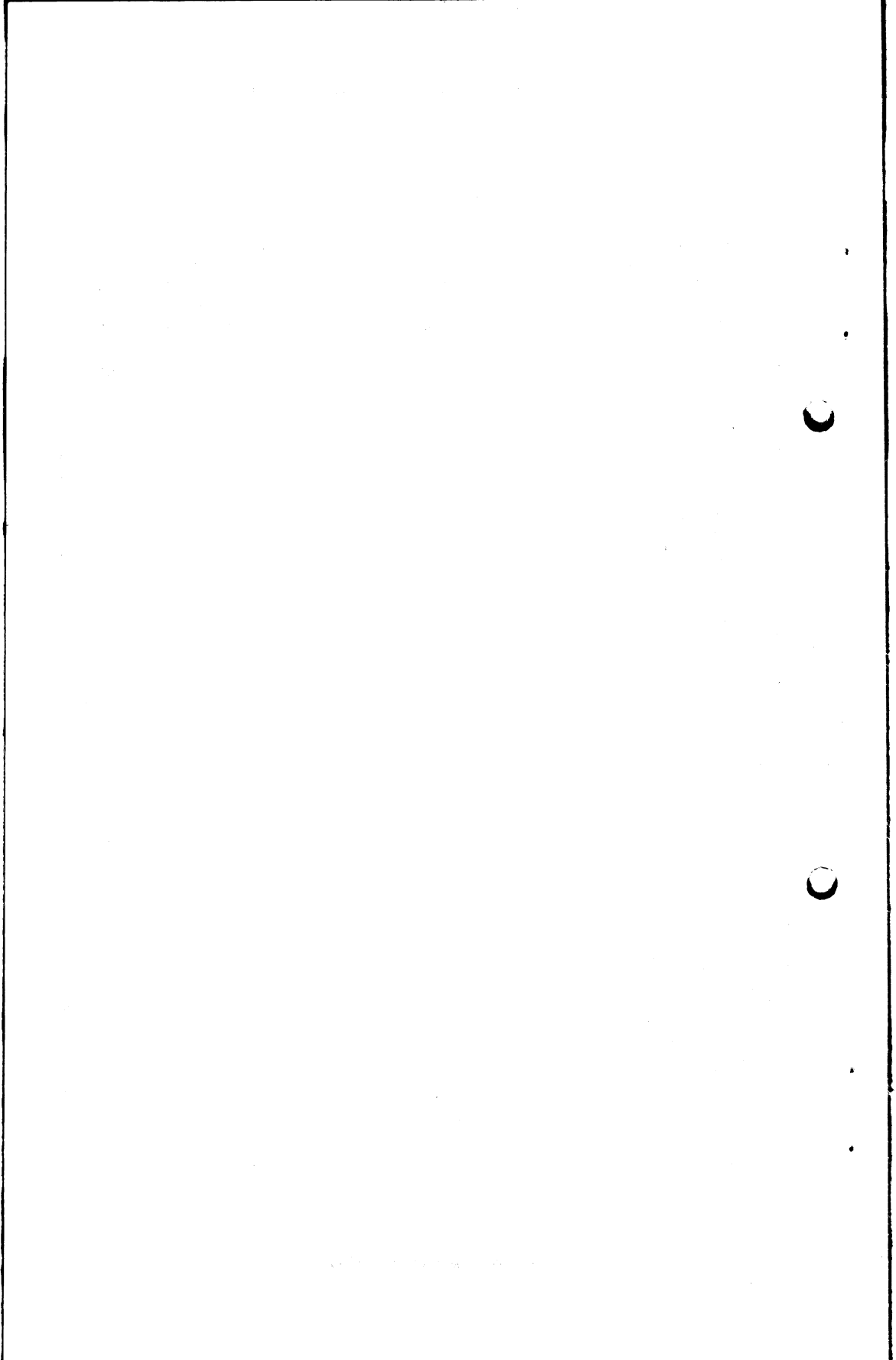

THE INDUSTRIAL RELATIONS ACT, 1980

(Act No. 4 of 1980)

THE GUIDELINES (INDUSTRIAL COURT) NOTICE, 1984

(Under section 5)

In exercise of the powers conferred by section 5 of the Industrial Relations Act, 1980 the Minister for Labour and Public Service hereby issues the following Notice —

Citation.

1. This Notice may be cited as the Guidelines (Industrial Court) Notice, 1984 and shall come into force on the 2nd March, 1984.

Guidelines.

2. In exercise of its powers under the Act, the Court shall take into consideration the following guidelines —

- (a) the necessity to maintain and wherever possible expand the level of employment in all sectors of economic activity;
- (b) the necessity to ensure that employees are fairly rewarded for their part in increasing production in undertakings taking into account the effect of the Customs Union Agreement on the Swaziland cost of living;
- (c) the necessity for the establishment and maintenance of reasonable differentials in rewards between different categories of employees taking account of their skills and levels of responsibility;
- (d) the necessity to maintain and if possible improve the standard of living of employees;
- (e) the necessity to preserve and where possible improve the competitive position of products of Swaziland in both domestic and overseas markets;
- (f) the need to ensure the continued ability of the Government to finance development programmes and recurrent expenditure in the public sector;
- (g) the necessity to take into account the Government Policy of Equal Pay for Equal Work, ensuring that there is no salary, wage or conditions of service discrimination of any sort.
