GENERAL NOTICE NO. 43 OF 1984

THE LAW REFORM AND DEVELOPMENT COMMISSION (AMENDMENT)
NOTICE, 1984

In exercise of the executive powers vested in me, I, NTOMBI, Ndlovukazi and Regent of the Kingdom of Swaziland, do hereby issue the following Notice:—

Title and Commencement.

1. This Notice may be cited as the Law Reform and Development Commission (Amendment) Notice, 1984, shall be read as one with the Law Reform and Development Commission Notice, 1981 (herein-after referred to as "the Notice") and shall come into force on the 11th day of May, 1984.

Amendment of paragraph 1.

2. The Notice is amended by replacing paragraph (1) with the following:—

1. (a) The Commission shall consist of the following persons:—

Minister for Justice	Chairman
Khalalempi M. Mndzebele	Member
Siboniso C. Dlamini	"
Mrs. Mary Mdziniso	"
Mr. O.Z. Dhlamini	"
Knox M. Nxumalo	"

Attorney-General	"
A legally qualified person to be appointed by the Commission	"
A Legal Advisor to be appointed ad hoc by the Commission	"

(b) There shall be a Secretary to be appointed by the Minister for Justice.

Amendment of paragraph 2.

3. The Notice is amended in paragraph 2 by replacing the word "four" with the word "six".

Addition of new paragraph.

4. The Notice is amended by adding the following paragraph after paragraph 5:—

"Remuneration, fees and allowances, etc".

6. The members and officers of the Commission shall be paid such remuneration, fees and allowances as the King may determine and such expenditure shall be paid from public funds".
