Citation and commencement.

1. This Notice may be cited as the Maximum Wholesale and Retail Selling Prices of Soft Drinks (Amendment) Notice, 1986, shall be read as one with the Maximum Wholesale and Retail Selling Prices of Soft Drinks Notice, 1985 and shall come into force on the 14th February, 1986.

THE CENTRAL BANK OF SWAZILAND ORDER, 1974

(Order No. 6 of 1974)

THE PRESCRIPTION OF RESERVES NOTICE, 1986

(Under Section 40)

In exercise of the powers conferred by section 40 of the Central Bank of Swaziland Order 1974 I hereby issue the following Notice—

Citation and commencement.

1. This Notice may be cited as the Prescription of Reserves Notice, 1986 and shall be deemed to have come into force on the 1st January, 1986.

Prescription of reserves.

2. The Central Bank of Swaziland hereby prescribes that a financial institution licensed under section 6 of the Financial Institutions (Consolidation) Order, 1975 shall maintain reserves equal to six per cent of the total deposits for which it is liable to the public in Swaziland excluding any balances for which it is liable to any financial institution and such reserves may be maintained by way of deposits with the Central Bank which bear no interest or by way of holding of notes and coins issued by the Central Bank or by both without restriction as to proportions.
