GENERAL NOTICE NO. 14 OF 1986

THE CENTRAL BANK OF SWAZILAND ORDER, 1974 (KING'S ORDER-IN-COUNCIL NO. 3 OF 1974) CORONATION COMMEMORATIVE COINS

(Under section 24(3))

In exercise of the powers conferred by the Central Bank of Swaziland Order, 1974, I hereby issue the following Notice —

Citation.

1. This Notice may be cited as the "Coronation Commemorative Coins Notice".

Interpretation.

2. In this Notice unless the context otherwise requires —

"commemorative Coins" or "commemorative issue" means Coronation Commemorative coins issued under this Notice.

Commemorative Issue.

3. The coins to be issued by the Central Bank of Swaziland shall be a special commemorative issue to mark the accession of Crown Prince Makhosetive to the throne.

Denomination, Material, Dimension, Weights and Quantities.

4. The commemorative issue shall consist of coins of the following denominations, material, dimensions, weights and quantities.

| Denomination | Material | Diameter in Millimetre | Weights in Grams | No. of Coins to be Minted. |
|--------------|-------------|---------------------------|---------------------|----------------------------|
| E250 | .916.6 Gold | 28.4 | 15.98 | 500 |
| E 25 | .925 Silver | 38.61 | 28.28 | 2,500 |

Shape of Commemorative Coins.

5. The two Commemorative Coins shall be round and with milled edges.

Inscription.

- 6. The commemorative coins shall bear the following designs and inscriptions—
 - (i) On the obverse side of the 250 (two hundred and fifty) Emalangeni, and the 25 (twenty five) Emalangeni shall be engraved and inscribed:
 - (a) in the centre, the image of His Majesty.
 - (b) along the upper edge above the image of His Majesty and following the curve of the coin the words in one line in the English Language "Accession April, 25th 1986".
 - (c) along the lower edge below the image of His Majesty and following the curve of the coin the words in one line in the English Language "His Majesty King Makhosetive".
 - (ii) On the reverse side of the E250 (two hundred and fifty Emalangeni) gold coin and E25 (twenty five Emalangeni) silver coins —
 - (a) in the centre, the image of Indlovukati.
 - (b) along the upper edge above the image of Indlovukati the number 250 and 25 in Arabic numerals and the word "Emalangeni" on the gold and silver coins respectively.
 - (c) along the lower left hand edge and following the curve of the coin the word "SWAZILAND".
