

#### THE PREVENTION OF CORRUPTION ACT, 1986

(Act No. 5 of 1986)



## I ASSENT

NTOMBI Ndlovukazi and Regent of Swaziland 7th April, 1986

## AN ACT entitled

An Act to provide for the prevention of corruption.

ENACTED by the Regent and the Parliament of Swaziland.

#### Short title.

1. This Act may be cited as the Prevention of Corruption Act, 1986 and shall come into operation on such date as the Minister may, by notice in the Gazette appoint.

#### Interpretation.

2. In this Act, unless the context otherwise requires-

"consideration" means consideration of any kind whether valuable or not;

"public corporation" means any body, whether corporate or unincorporate, in which the Government, the Swazi Nation or the Swazi National Treasury holds shares or any financial or monetary interest and include any body in which such corporation holds shares or any monetary or financial interest.

#### Application.

- 3. This Act shall apply to any person who holds office ----
  - (a) in respect of which emoluments or allowances are payable from public funds or from the Swazi National Treasury;
  - (b) in a public corporation;
  - (c) in a local authority;
  - (d) in a company, society or voluntary association.

#### Prohibition of offer of gift or consideration.

4. A person who corruptly offers or gives any gift or consideration to any person to whom this Act applies, as an inducement or reward for doing or forebearing to do, in his official capacity, any act shall be guilty of an offence.

#### Prohibition of acceptance of gift or consideration.

5. A person to whom this Act applies, who corruptly accepts, agrees to accept or attempt to obtain from any other person, for himself or for any other person, any gift or consideration, knowing or having reason to suspect that it was made as an inducement or reward for—

- (a) doing or forebearing to do, in his official capacity, any act; or
- (b) showing or forebearing to show, in his official capacity, favour or disfavour, shall be guilty of an offence.

#### Penalties.

6. (1) A person who is guilty of an offence under this Act shall be liable on conviction to a fine not exceeding two thousand Emalangeni or imprisonment for a period not exceeding five years or to both such fine and imprisonment.

(2) The court convicting a person under subsection (1) may in addition, order the forfeiture of such gift or consideration or give summary judgment in favour of the Government for an amount equal to the value of any such gift or consideration, together with any interest that may have accrued thereon.

(3) A judgment given by a court under subsection (2) shall have the same force and may be executed in the same manner as if the judgment had been given in a civil action instituted in the Court.

#### Presumptions and construction.

- 7. (1) Where it is proved in any prosecution for an offence under this Act that-
  - (a) a person to whom this Act applies has accepted, obtained, agreed to accept or attempted to obtain any gift or consideration for himself or for any other person;
  - (b) any person has given, agreed to give or offered any gift or consideration to a person to whom this Act applies for himself or for any other person,

it shall be presumed, unless the contrary is proved, that he did so in contravention of this Act.

(2) Nothing in this Act shall be construed as prohibiting any lawful act relating to the giving or receiving of a gift or consideration in accordance with Swazi law and custom in the form of a bona fide setfulo, sipheko or similar practice.

An Act to amend the Criminal Procedure and Evidence Act, 1938.

ENACTED by the Regent and the Parliament of Swaziland.

#### Short title.

1. This Act may be cited as the Criminal Procedure and Evidence (Amendment) Act, 1986 and shall be read as one with the Criminal Procedure and Evidence Act, 1938.

#### Addition of section 185 bis.

2. The Criminal Procedure and Evidence Act, 1938 is amended by inserting after section 185 the following new section —

"Sentence for rape etc.

185 bis (1) A person convicted of rape shall, if the Court finds aggravating circumstances to have been present, be liable to a minimum sentence of nine years without the option of a fine and no sentence or part thereof shall be suspended.

(2) The proceedings in a case of rape, including the proceedings where a person is charged with having unlawful carnal connection with a girl under the age of sixteen years or with a female idiot or imbecile shall be held in camera if at any time the victim so requests or the Court so determines.

(3) A person who in connection with proceedings under this section publishes any information as to -

- (a) the identity of a viction of rape or of a girl under the age of sixteen years or of a female idiot or imbecile;
- (b) the place where the offence in question was alleged to have been committed; or
- (c) the name of any witness,

shall be guilty of an offence and liable on conviction to a fine of one thousand Emalangeni or imprisonment for two years." S4

(Act No. 7 of 1986)

#### AN ACT

#### entitled

An Act to amend the Crimes Act, 1889.

ENACTED by the Regent and the Parliament of Swaziland.

#### Short title.

1. This Act may be cited as the Crimes (Amendment) Act, 1986 and shall be read as one with the Crimes Act, 1889.

#### Amendment of Chapter 4.

2. Chapter 4 of the Crimes Act, 1889 is amended by adding the following new section immediately after section 80 -

"Unlawful possession etc., of human body or part thereof

- 80 bis (1) Any person who --
- (a) is in unlawful possession of a human body or part thereof;
- (b) receives, retains or conveys a human body or part thereof which he knows to have been unlawfully obtained;
- (c) with intent to remove, excise or extract any part of a human body or to do any similar act
  - (i) abducts, confines, kidnaps or assaults another person; or
  - (ii) maims, mutilates, disfigures or dismembers a human body or does any similar act; or
- (d) counsels, procures, incites, persuades, recommends, directs or orders any other person to do any act which is an offence under this section

shall be guilty of an offence and shall on conviction be liable to a term of imprisonment not exceeding fifteen years without the option of a fine. (2) Any person who knows of any other person who has unlawful possession of a human body or part thereof and, without reasonable cause, fails to report such other person to a police officer or to a chief, indvuna or umgijimi within twenty-four hours of such knowledge shall be guilty of an offence and on conviction shall be liable to a term of imprisonment not exceeding five years without the option of a fine.

(3) In any proceedings under this section where the prosecution proves that the body or part of a body relating to the alleged offence is that of a human being —

- (a) the onus shall be on the accused to prove that the act, possession or intention relating to the offence was not unlawful;
- (b) the question as to whether the body or part of a body is that of a living person or a deceased person or of any particular person shall be immaterial.

(4) Where a person is charged with murder or culpable homicide and the evidence is sufficient to prove an offence under sub-section (1) but not to prove murder or culpable homicide, the Court may convict such person of an offence under that subsection as if he had been charged with that offence.

(5) Notwithstanding section 20 of the Criminal Procedure and Evidence Act, 1939, no prosecution under this section shall be barred by the lapse of time specified in that section.

(6) Nothing in this section shall be construed as prohibiting any lawful act —

- (a) in pursuance of a burial, interment or any other mode of disposal of a body or part thereof including its disposal in accordance with any law or Swazi law and customs; or
- (b) for the purpose of bona fide medical, dental, scientific or educational research, practice or study or any other similar purpose in accordance with a written authority issued by the Minister responsible for health.

#### THE CENTRAL BANK OF SWAZILAND (AMENDMENT) ACT, 1986

(Act No. 8 of 1986)

#### AN ACT entitled

An Act to amend the Central Bank of Swaziland Order, 1974. ENACTED by the Regent and the Parliament of Swaziland.

#### Short title.

1. This Act may be cited as the Central Bank of Swaziland (Amendment) Act, 1986, shall be read as one with the Central Bank Order, 1974 (hereinafter referred to as "the Order") and shall come into operation on 1st July, 1986.

Amendment of section 4.

2. Section 4 of the Order is amended by inserting after paragraph (a) the following paragraph -

"(aa) to issue securities on its own account."

Amendment of section 8.

- Section 8 of the Order is amended by replacing subsection (2) with the following —
   "(2) After the appropriate allocation has been made to general reserve under
   subsection (1) the remainder of the net profits for the financial year—
  - (a) shall be applied to the redemption on behalf of the Government of any securities issued and outstanding under section 6(5) or 35(2);
  - (b) may be transferred to any special fund established under section 41 *bis* in such amounts as the board may determine."

#### Amendment of section 21.

4. Section 21 of the Order is amended by adding the following subsection after subsection (2)—

"(3) the external value of the lilangeni may be determined from time to time in a manner, proposed by the Central Bank and approved by the Minister."

#### Replacement of section 23.

5. Section 23 of the Order is replaced with the following section—

#### "Legal tender

23. Only notes and coins which are issued by the Central Bank and which may be exchanged by the Central Bank at full value under section 26 shall be legal tender in Swaziland in the case of—

- (a) notes or gold coins, for the payment of any amount;
- (b) coins, for the payment of any amount not exceeding ten Emalangeni."

#### Amendment of section 30.

6. Section 30 of the Order is amended by replacing paragraph (a) with the following— "(a) the reserve tranche position of Swaziland in the General Resources Account of the International Monetary Fund."

Amendment of section 37.

- 7. Section 37 of the Order is amended in subsection (2)-
  - (a) in paragraph (a) by replacing the words "123 days" with the words "one hundred and eighty days";
  - (b) in paragraph (b) by replacing the words "123 days" with the words "one hundred and eighty days";
  - (c) by inserting after paragraph (b) the following paragraph
    - "(bb) purchase and sell in the open market securities issued by the Central Bank";
  - (d) in paragraph (c) by replacing the words "123 days" with the words "one year";
  - (e) in paragraph (c) (i) by replacing subparagraph (aa) with the following— "(aa) instruments referred to in paragraph (a) or (b) or subparagraph (bb)."

Addition of section 41 bis.

8. The Order is amended by inserting after section 41 the following new section —

"Establishment of special funds.

- 41 bis. (1) The Minister may direct the Central Bank to establish a special fund or such number of special funds as may be necessary for the financing of such small businesses or general development as he may determine where after consultation with the Central Bank the Minister is of the opinion that the establishment of such funds is necessary.
  - (2) Any fund established under subsection (1) shall consist of amounts-
    - (a) appropriated by the Government for purposes of the fund;
    - (b) contributed by any donor;
    - (c) transferred by the Central Bank to the fund under section 8;
    - (d) accruing to the fund from any other source.

(3) A special fund shall be held in trust and administered by the Central Bank as the sole trustee for facilitating economic development through—

- (a) the making of loans and advances on such terms and conditions as the Central Bank may determine, to such bodies as the Minister may, after consultation with the Central Bank approve;
- (b) the purchase, holding or sale of debentures, bonds and other obligations maturing within eight years from the date of acquisition thereof by the Central Bank and issued by the bodies approved by the Minister under paragraph (a);
- (c) the participation by the Central Bank in programme to guarantee loans made by financial institutions to bodies approved by the Minister under paragraph (a) where the Minister is of the opinion that such bodies should be accorded priority for the economic development of Swaziland."

#### Repeal.

9. The Currency Order, 1974 is hereby repealed.

#### entitled

An Act to provide for the appropriation of a certain sum of money for the financial year commencing on the 1st April, 1986 and ending 31st March, 1987.

ENACTED by the Regent and the Parliament of Swaziland.

#### Short title and commencement.

This Act may be cited as the Appropriation Act, 1986 and shall be deemed to have 1. come into force on the 1st April, 1986.

#### Charge to Consolidated Fund.

2. The Consolidated Fund is charged with such sum of money not exceeding in the aggregate two hundred and seventy-two million, nine hundred and seventy-five thousand Emalangeni (E272,975,000) as required for the services of the Government of the Kingdom of Swaziland during the financial year commencing on the 1st April, 1986 and ending on the 1st March, 1987.

3. The sum appropriated by section 2 shall be applied to the services set out in the first column of the Schedule and in the respective amounts appearing in the second column and third columns in respect of each service.






