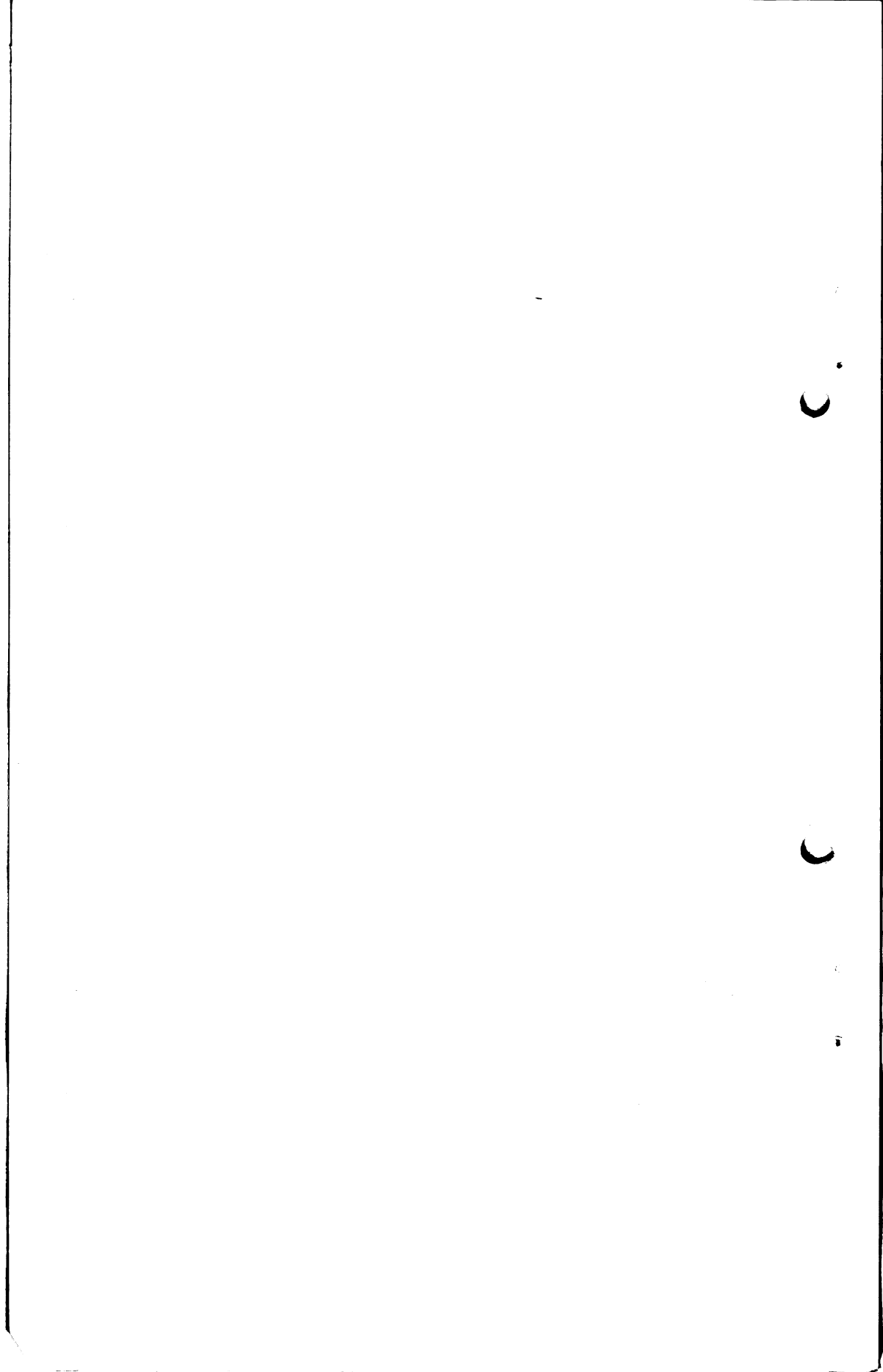

KING'S DECREE NO. 1 OF 1986

THE KING'S PROCLAMATION (AMENDMENT) DECREE , 1986

In exercise of the powers vested in me and in accordance with paragraph 14 of the King's Proclamation to the Nation of the 12th April, 1973 , I, MSWATI III, King of Swaziland, hereby make the following Decree :

Short title.

1 . This Decree may be cited as the King's Proclamation (Amendment) Decree , 1986 and shall be read as one with the King's Proclamation to the Nation of the 12th April, 1973.

Amendment of paragraph 3 of Decree.

2 . Paragraph 3 of the Decree contained in the King's Proclamation is hereby amended in subsection (2) of section 28 of the repealed Constitution by adding at the end of that subsection the words "and may delegate any of his powers and functions ."

THE KING'S DELEGATION OF POWERS NOTICE, 1986

In exercise of the powers vested in me under paragraph 3 of the Decree contained in the King's Proclamation to the Nation of the 12th April, 1973, I, MSWATI III, King of Swaziland hereby issue the following Notice:

Title.

1. This Notice may be cited as the King's Delegation of Powers Notice, 1986.

Delegation of Powers and functions.

2. The Powers and functions of the King to do any thing that belongs to his office may, upon the exercise of such powers or the performance of such functions, be signified by the Ndlovukazi Ntombi after consultation with the King.
