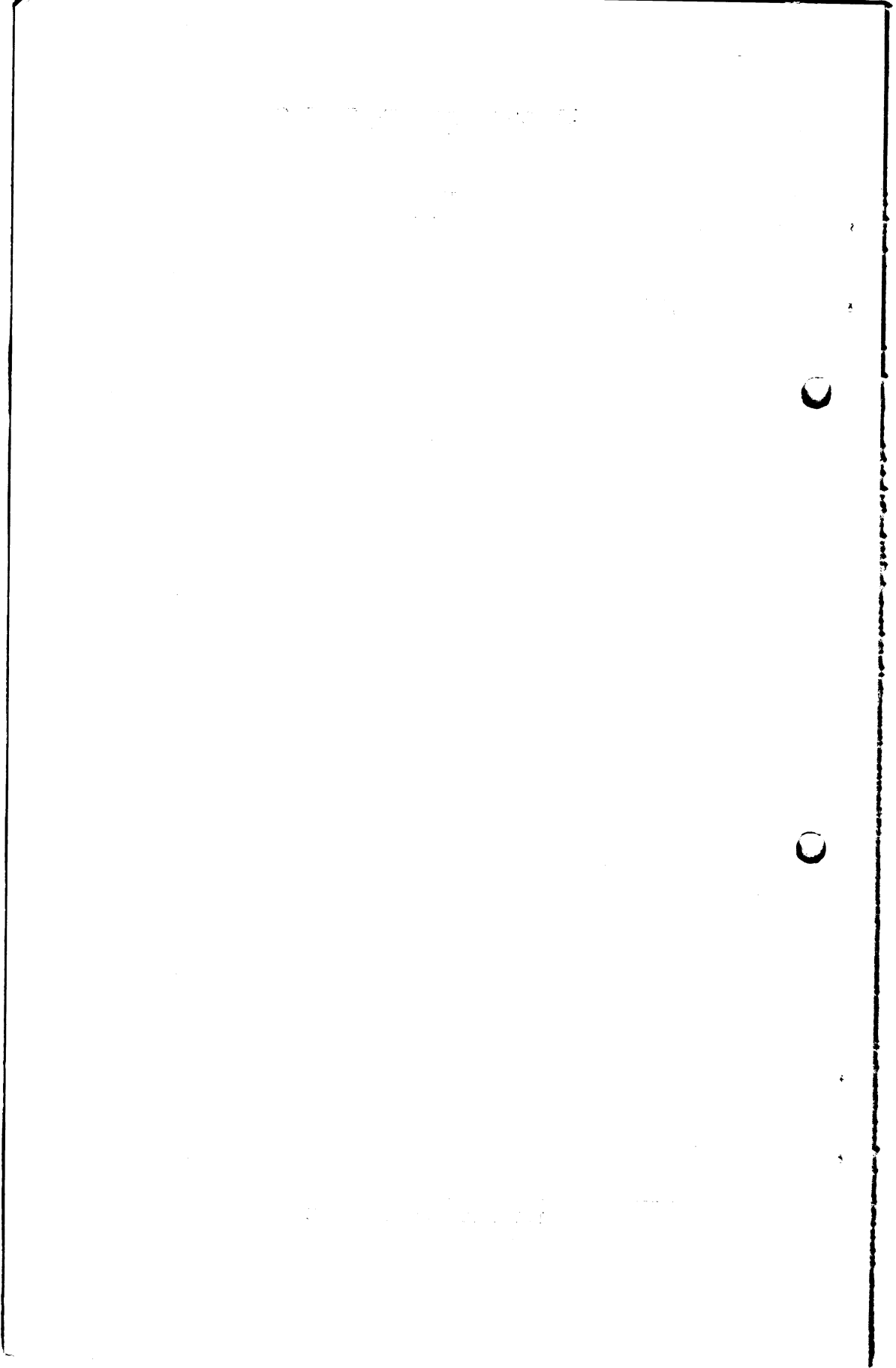

## THE SWAZILAND TELEVISION AUTHORITY ACT, 1983

(Act No. 1 of 1983)

THE TELEVISION VIEWERS (CERTIFICATES AND LICENCES)  
(AMENDMENT) REGULATIONS, 1986

(Under Section 26)

In exercise of the powers conferred by section 26 of the Swaziland Television Authority Act, 1983 the Minister for Interior and Immigration, after consultation with the Board of Directors, hereby makes the following Regulations —

*Citation and commencement.*

1. These Regulations may be cited as the Television Viewers (Certificates and Licences) (Amendment) Regulations, 1986 shall be read as one with the Television Viewers (Certificates and Licences) Regulations, 1983 (hereinafter referred to as "the principal Regulations") and shall come into force on 1st November, 1986.

*Amendment of regulation 2.*

2. Regulation 2 of the principal Regulations is amended by replacing paragraph (a) with the following paragraph—

- "(a) a monthly fee of fifteen Emalangeni for a colour television receiver and eight Emalangeni for nonportable monochrome television receiver on or before the 1st of each month:

Provided that the fees payable in this paragraph shall be subject to the rebates set out in the First Schedule hereto.

*Amendment of regulation 4.*

3. Regulation 4 of the principal Regulations is amended after the words "set out in the" by replacing the word "Schedule" with the words "Second Schedule".

*Amendment of Schedule.*

4. The Schedule to the principal Regulations is amended by replacing the heading "SCHEDULE" with the heading "SECOND SCHEDULE".
