LEGAL NOTICE NO. 85 OF 1987

THE STOCK DISEASE REGULATIONS, 1933

THE LIVESTOCK DIPPING FEES NOTICE, 1987

(Under Regulation 11 and 13)

In Exercise of the powers conferred by Regulation 11 and 13 of the Stock Disease Regulations 1933, the Minister for Agriculture and Co-operatives hereby issues the following Notice:-

Citation and Commencement.

1. This Notice may be cited as the Livestock Dipping Fees Notice, 1987 and shall come into force on 1st October, 1987.

Declaration of Scale of Fees.

2. All cattle owners on all Government dip tanks shall pay an annual fee of E2.00 (two Emalangeni) per animal as dipping fees.

Recovery of Dipping Fees.

3. All fees shall be paid by cattle owners based on the number of cattle stated on a debit note issued by the Ministry within three (3) months of the issue of such debit notes at Government Revenue Offices or the Offices of the Ministry of Agriculture and Co-operatives specified in the Schedule.

LEGAL NOTICE NO. 86 OF 1987

THE ANIMAL DISEASE ACT, 1965

THE STOCK DISEASE (AMENDMENT) REGULATIONS, 1987

(Under Section 3)

In Exercise of the powers conferred by Section 3 of the Animal Disease Act, 1965, the Minister for Agriculture and Co-operatives hereby issues the following Regulations:—

Citation and Commencement.

1. These regulations may be cited as the Stock Disease (Amendment) Regulations, 1987, shall be read as one with the Animal Disease Regulations, 1933 and shall come into force on the 1st October, 1987.

Amendment of Regulation 11(4).

2. Regulation 11(4) of the Stock Disease Regulations, 1933 is amended by replacing it with the following:—

"11(4). A person who fails or neglects to pay fees made under Regulation 11(3) shall be guilty of an offence and liable upon conviction by a court to a fine not exceeding Five Hundred Emalangeni (E500.00) or to imprisonment for a period not exceeding six (6) months:

> Provided that the court shall, in addition to passing sentence further order the person to pay the fees owed within a specified period failing which the court may further order the sale of the person's stock by public auction to recover the fees owed."
