(Under Section 5)
In exercise of the powers conferred by Section 5 of the Price Control Order, 1973, I hereby issue the following Notice:

## Citation and Commencement.

1. This notice may be cited as the Maximum Wholesale and Retail Selling Prices of Soft Drinks Notice, 1989, and shall come into force on 14 July, 1989.

## Maximum Prices of Soft Drinks

2. The maximum wholesale and retail selling prices of soft drinks shall be as set out in the schedules hereto.

3. The Maximum Wholesale and Retail Selling Prices of Soft Drinks Notice, 1988 is hereby revoked.

## MAXIMUM WHOLESALE AND RETAIL PRICES OF BREAD NOTICE, 1989 (Under Section 5)

In exercise of the powers conferred upon me by Section 5 of the Price Control Order, 1973 I hereby issue the following Notice:

## Citation and Commencement

1. This Notice may be cited as the Maximum Wholesale and Retail Prices of Bread Notice, 1989 and shall come into force on the 14th July, 1989.

## Maximum Prices of Bread.

2. The maximum wholesale and retail prices of bread other than fancy bread, shall be as set out in the schedule hereto.

Revocation of Legal Notice No. 134 of 1988.
3. The Maximum Wholesale and Retail Prices of Bread Notice, 1988 is hereby revoked.
