(Act No. 1 of 1990)

#### AN ACT

#### entitled

An Act to provide for the appropriation of a certain sum of money for the financial year commencing on the 1st April, 1990 and ending 31st March, 1991.

ENACTED by the King and the Parliament of Swaziland.

Short title and commencement.

1. This Act may be cited as the Appropriation Act, 1990 and shall be deemed to have come into force on the 1st April, 1990.

Charge to Consolidated Fund.

2. The Consolidated Fund is charged with such sum of money not exceeding in the aggregate seven hundred and seven million, nine hundred and twenty five thousand Emalangeni (E707,925,000) as required for the service of the Government of the Kingdom of Swaziland during the financial year commencing on the 1st April, 1990 and ending on the 31st March, 1991.

Application of sum appropriated.

3. The sum appropriated by Section 2 shall be applied to the services set out in the first column of the Schedule and in the respective amounts appearing in the second and third columns in respect of each service.
