ASSESSMENT RATES FOR THE FINANCIAL YEAR ENDING 31ST MARCH, 1992

 - (iv) whether anything can be done to save the farmer the trouble of transporting rejected maize back to his farm. In this regard, specifically examine:
 - the extent to which available extension advice on farm-level maize-drying and treatment for storage pests is followed by the farmers in general;
 and

- the cost implications to the farmer of providing maize furnigation and drying facilities at the mill by National Maize Corporation;
- (b) the condition of the silos, both physical and mechanical;

(c) the reasons behind the inability of the mill to supply the maize meal needs of all shops in Swaziland sometimes.

Enquiry venue.

4. The Enquiry shall be held at the Crop Production Offices of the Ministry of Agriculture and Co-operatives in Manzini at such times as the Commission may determine.
