THE FINANCE AND AUDIT (AMENDMENT) ACT, 1992

(Act No. 3 of 1992)



I ASSENT

MSWATI III

King of Swaziland

8th May, 1992

AN ACT

entitled

An Act to Amend the Finance and Audit Act, 1967.

ENACTED by the King and the Parliament of Swaziland.

Short title.

1. This Act may be cited as the Finance and Audit (Amendment) Act, 1992 and shall be read as one with the Finance and Audit Act, 1967 in this Act referred to as the "principal Act".

Replacement of short title.

2. The short title of the principal Act is replaced with the following:

"Short title.

This Act may be cited as the Finance Management and Audit Act 1967".

Amendment of Section 2.

3. Section 2 of the principal Act is amended by replacing the definition "financial and accounting instructions" with the following new definition:

"Financial Management and Accounting Regulations" means regulations made by the Minister under Section 26 and includes the instructions and regulations referred to in Section 3;"

Amendment of Section 4.

4. Section 4 of the principal Act is amended by inserting after subsection (1) the following new subsections:

“(1) bis Any warrant issued under subsection (1) by the Minister for the withdrawal from the Consolidated Fund of any money authorized by an Appropriation Act for the financial year to meet expenditure on any service of Government shall lapse at the expiration of the financial year if at that time such money has not been expended for the purpose authorized by the Appropriation Act in respect of that financial year:

Provided that if any such money has already been committed to the payment of duly approved Government orders made before 31st March of the relevant financial year but which orders have not been fulfilled before that date the relative warrant shall lapse after 30th day of June following the expiration of the financial year in respect of which the warrant was issued”.

Amendment of Section 5.

5. Section 5 of the principal Act is amended by replacing paragraph (b) of the provide thereto with the following:

(b) “the expenditure so authorized for any service shall not exceed one quarter of the amount appropriated for that service in the Appropriation Act for the immediately preceding financial year; and”

Amendment of Section 4.

6. Section 6 of the principal Act is amended by replacing subsection (2) with the following:

“(2) the total advances made under subsection (1) shall not at any time exceed the sum of E3,000,000:

Provided that this limit shall not apply when an advance is made for the purpose of onlending to a statutory body or any other organisation in which the Government has a financial interest”.

Amendment of Section 7.

7. Section 7 of the principal Act is amended by replacing the figure “E2,000,000” in subsection (2) with the figure “20,000,000.”

Amendment of Section 18.

8. Section 18 of the principal Act is amended as follows:

(a) by replacing subsection (1) with the following:—

“(1) Within six months after the end of each financial year the Accountant-General shall sign and submit to the Auditor-General accounts showing fully the financial position of the Consolidated Fund and other funds on the last day of such financial year:

Provided that the time allowed for the submission of the accounts by the Accountant-General may be extended by the Minister for a further period not exceeding two months”;

(b) by inserting after paragraph (e) of subsection (3) the following new paragraph:

(c) “a statement of trading and special funds”.

Replacement of Section 22.

9. Section 22 of the principal Act is replaced with the following:

"Notification of surcharge.

22(1) The Principal Secretary shall cause the Auditor-General and the controlling officer of the department concerned to be notified of any surcharge made under Section 21.

(2) The controlling officer on receiving such notification shall notify the person surcharged and advise the Accountant-General to withhold or defer the payment of any terminal benefits which may be due to the person surcharged.

(3) The Accountant-General shall recover the amount surcharged from the person who has been surcharged".

Replacement of Section 23.

10. Section 23 of the principal Act is replaced with the following:

"Withdrawal of surcharge

23 The Principal Secretary may at any time withdraw any surcharge in respect of which a satisfactory explanation has been received or if it otherwise appears that no surcharge should have been made, and in any event the Principal Secretary shall notify the Auditor-General, the Accountant-General and the controlling officer of the department concerned of the withdrawal of the surcharge".

Amendment of Section 26.

11. Section 26 of the principal Act is amended by replacing the words "financial and accounting instructions" wherever they appear therein with the words "Financial Management and Accounting Regulations".

THE WAGES ACT NO. 16 OF 1964

THE REGULATION OF WAGES (DOMESTIC EMPLOYEES) ORDER, 1992

(Under Section 11)

In exercise of the powers conferred upon me by Section 11 of the Wages Act, 1964, I, the Minister for Labour hereby make the following order—

Citation.

1. This Order may be cited as the Regulation of Wages (Domestic Employees) Order, 1992 and shall be deemed to have come into effect on the 1st March, 1992.

Interpretation.

2. In this Order, unless the context otherwise requires:—

“casual employee” means a domestic employee who is employed for not more than one day at a time and who is paid at the end of the day’s work;

“children’s nurse” means a person who takes care of children and oversees their activities, gives children all necessary assistance, carries out such other duties in connection with the care of children, including the washing of their clothes, as may be required;

“cook” means a person who is capable of, and is mainly engaged in, preparing and cooking meals suitable to the dietary and other requirements of the household in which he is employed and who may be required to assist in other household duties;

“domestic employee” means any person employed in or about any private household or part thereof in capacity of cook, house attendant, waiter, butler, children’s nurse, valet, groom, gardener, laundress, or watchman;

“gardener” means a person who carries out all gardening activities, including the planting and cultivation of flowers, shrubs and vegetables, maintains lawns and paths and attends to cleanliness of compounds and yards and, who may be required to carry out other duties such as cleaning vehicles;

“house attendant” means a person who carries out domestic duties including the preparation of food, washing of dishes, cleaning rooms, dusting and polishing furniture, washing windows, washing clothes and textiles by hand and ironing them, making beds etc;

“Laundress” means a person who is mainly employed to carry out washing of clothing using either the washing machine or washing the clothing by hand and ironing them using any kind of iron;

“part time employee” means a domestic employee, other than a casual employee, who is employed for less than twenty four hours in any week;

“public holiday” means a public holiday mentioned in the Second Schedule;

“watchman” means a person who is responsible for the safeguard of his employer’s property against fire, theft and illegal entry; carries out such other duties as are similar to these responsibilities, as required by his employer;

Application.

3. This Order shall apply to all persons employed as domestic employees as specified in the First Schedule.

Basic minimum wage.

4. (1) The basic minimum wage to be paid to employees specified in the First Schedule shall be calculated at a rate not less than that specified therein.

(2) The daily and hourly rates specified in the First Schedule shall be the basic minimum wage applicable to part time and casual employees only.

Conditions of Employment.

5. As a condition of employment, an employee may enter into a written agreement with his employer.

Hours of work.

6. The normal working week shall consist of forty-eight hours, exclusive of meal breaks, spread over six days of the week each of either eight hours or as may be agreed between the employer and the employee.

Annual leave.

7. (1) After twelve months of continuous service with an employer, an employee shall be entitled to twelve working days leave and shall be paid for such leave the wages (excluding overtime) he would have earned had he worked during the period of such leave.

(2) Where a public holiday occurs during the period of annual leave granted to an employee under the provisions of this section, the employee will be paid a day's wages for that public holiday in addition to the wages payable to him in respect of his annual leave.

(3) Where the employment of an employee is terminated after a period exceeding three months from the date of its commencement, or after a period following the date on which annual leave granted under this section ended, the employee shall be paid, in addition to any other entitlement, an amount equal to one day's pay for each month of service during which he has earned, but has not taken annual leave.

Sick leave.

8. (1) After three months service with an employer, and subject to the production of a medical certificate of incapacity signed by a registered medical practitioner or registered nurse covering the period of absence, an employee shall be entitled during each period of twelve months employment, to fifteen working days sick leave on full pay.

(2) Sick leave granted under the provisions of this paragraph shall not be cumulative and shall not be carried forward from one year to another.

(3) An employer may in lieu of the medical certificate referred to in sub-section (1) accept such other evidence of incapacity as he considers appropriate in the circumstances of the case.

Maternity leave.

9. (1) After nine months of continuous service with an employer, and subject to the production of a certificate signed by a registered nurse recommending that an employee should refrain from work because she is pregnant, an employee shall be entitled to thirteen working days maternity leave on full pay thereafter without pay in respect of that pregnancy.

(2) Such leave shall be in addition to any sick leave to which the employee may be entitled under Section 8.

Public holidays.

10. An employee required to work on a public holiday specified in the Second Schedule shall be paid, in addition to the wages he would normally earn on that day, an additional day's wages or, alternatively, by mutual agreement between himself and his employer, he may be granted another day off work on full pay at a time suitable to both parties.

Uniforms.

11. An employee shall, as a condition of employment, provide suitable uniform for the domestic employee, other than a domestic employee employed as a casual employee, or part time employee. Such uniform shall remain the property of the employer.

Rest day.

12. Every employee shall be granted one rest day each week; such day to be fixed by mutual agreement between the employee and his employer.

Overtime.

13. An employee required to work in excess of the normal hours of work referred to in Section 6 on any day or as agreed between the employee, shall be paid for such overtime at the rate of one and half times his normal rate of wages.

Accommodation.

14. Where an employer requires an employee to occupy accommodation provided by the employer as part of his conditions of employment, such accommodation shall be provided free of charge to the employee.

Revocation of Legal Notice No. 21 of 1985.

15. The Regulation of Wages (Domestic Employees) Order, 1985 is hereby revoked.

(Under Section 12)

The Disaster Relief Fund is hereby established with effect from 1st April, 1992.

LEGAL NOTICE NO. 57 OF 1992

THE FINANCE AND AUDIT ACT, 1967

(Act No. 18 of 1967)

THE ADMINISTRATION OF THE DISASTER RELIEF FUND REGULATIONS,
1992

(Under Section 12)

In the exercise of the powers conferred by Section 12 of the Finance and Audit Act, 1967 the Minister for Finance hereby makes the following Regulations—

Citation.

1. These Regulations may be cited as the Administration of the Disaster Relief Fund Regulations, 1992.

Disaster Relief Fund.

2. The following Regulations shall apply to the Disaster Relief Fund established by Legal Notice No. 56 of 1992.

- (a) The Fund shall be in the name of the Government of Swaziland.
- (b) There shall be paid into the Fund, moneys specifically appropriated to finance relief for disaster including donor finance for the provision of finance for disaster relief including moneys received as donations or grants.
- (c) The Fund shall be operated by the Accountant General with an account kept with the Central Bank of Swaziland.
- (d) All approved expenditure related to disaster relief shall be charged to the Fund in accordance with Government Accounting procedures.
- (e) All claims relating to the Fund shall be cleared within six months of the disaster period.
- (f) The committee shall approve all claims relating to the Fund.
- (g) All payments out of the Fund in respect of disaster relief shall not be re-imbursable by the beneficiaries thereof.
- (h) Government shall ensure that there is sufficient money in the Fund to cover any emergency relief.
- (i) The Minister for Finance shall appoint a committee of five persons who shall consider compensation resulting from the disaster and advise the Minister on any other matter relating to the payment of compensation to persons affected by the disaster.
