1. This Order may be cited as the Advance (Urban and Industrial Infrastructure Project) Order-in-Council, 1993

Interpretation.

2. In this Order, unless the context otherwise requires -
 "the recipient" means the Government of the Kingdom of Swaziland;
 "the Advance" means the advance raised by the Minister under section 3;
 "lender" means the International Bank for Reconstruction and Development;
 "Minister" means the Minister responsible for Finance.

Authority to raise Advance.

3. The Minister is hereby authorised to enter into (a letter of) agreement with the Lender for the purpose of raising an advance not exceeding one million United States dollars. (US \$1 000,000) approximately two million nine hundred and eighty thousand emalangeni (E2,980,000) upon the terms and conditions specified in this Order and upon such other terms and conditions as the Minister may consider appropriate.

Advance charges and repayments.

4. (a) The Advance withdrawn, shall be repayable, together with interest or service charge accrued based on the preceding semester plus one half percent (1/2 of 1%).

(b) As soon as practicable after the end of each Semester, the Lender shall notify the Recipient of the cost of Qualified Borrowings for that Semester.

The Minister is hereby authorised to enter into an Agreement with the Lender for the purpose of raising a loan not exceeding the equivalent of thirty nine million five hundred thousand Units of Account (BUA39,500,000) approximately E163,656,000 upon the terms and conditions specified in this Order and upon such other terms and conditions as the Minister may consider appropriate.

Loan charges and repayments.

4. (1) The loan shall be repayable in fifteen (15) years after a grace period of five (5) years, commencing from the date of signature of the Agreement, in thirty (30) consecutive semi-annual instalments, and the first such instalment shall be payable on the 1st January or the 1st July, whichever immediately follows the expiration of the grace period.
