## THE COMMISSION OF ENQUIRY ACT 1963

(Act No. 35 of 1963)

COMMISSION OF ENQUIRY INTO ALL ASPECTS OF LABOUR  
IN SWAZILAND (AMENDMENT) NOTICE, 1993

(Under section 3)

In the exercise of the powers conferred by section 3 of the Commission of Enquiry Act, 1963, the Minister for Labour and Public Service hereby issues the following Notice -

*Citation and commencement.*

1. This Notice may be cited as the Commission of Enquiry into all aspects of Labour in Swaziland (Amendment) Notice and shall be read as one with the Commission of Enquiry into all Aspects of Labour in Swaziland 1993 (hereinafter referred to as the "principal Notice") and shall come into force upon publication in the Gazette.

*Amendment of paragraph 1.*

2. Paragraph 1 of the principal Notice is amended by inserting the word "Relations" between the words "Labour" and "in Swaziland."

*Replacement of paragraph 2.*

3. Paragraph 2 of the principal Notice is replaced with the following -

*"establishment of Commission.*

2 (1) There is hereby established a commission to be known as the Commission of Enquiry into All Aspects of Labour Relations in Swaziland.

(2) The Commission shall comprise of the following persons -

Professor N.E. Wiehahn	Chairman
Mr. Jan Sithole	Member
Mr. Michael Robin Seal	Member"

*Amendment of paragraph 3.*

4. Paragraph 3 of the principal Notice is amended as follows:

- (a) by renumbering the existing paragraph as 3 (1) and;
- (b) by inserting the following new sub-paragraph (2)

" (2) In carrying out its functions in terms of sub-paragraph 1 here of, the Commission may invite members of the public to make verbal representations on any aspect of labour relations in Swaziland"

*Replacement of paragraph 6.*

5. Paragraph 6 of the principal Notice is replaces with the following

*"Duration of Enquiry.*

6. The Commission shall commence its functions as soon as possible after the publication of this Notice in the Gazette and shall submit its report to the Minister for Labour and Public Service by the 31st May, 1993 or such later date as the Minister may permit."
