ANIMAL DISEASE ACT 1965

(Act No. 7 of 1965)

THE STOCK DISEASE REGULATION, 1933

(Under Regulation 11)

In exercise of the powers conferred upon me by regulation 11 of the Stock Disease Regulation 33 I hereby issue the following:-

Citation.

1. This notice may be cited as the Dipping of Stock Notice 1993 and shall be deemed to have come into force on the 1st June, 1993.

Compulsory Dipping of Stock.

2. (i) Subject to paragraph (2) all owners of cattle in Swaziland shall dip their cattle once every fourteen (14) days.

(ii) Owners of cattle in schedule hereto shall dip their cattle once every twenty eight (28) days.

Dipping Hours.

3. Subject to any directions to the contrary issued by an officer authorised under regulation 11, dipping hours under regulation (2) of this notice shall be between 7.00 a.m. to 12 noon.

Revocation of Legal Notice No. 139 of 1991.

4. The dipping of stock order, 1992 is hereby revoked.
