AN ORDER- IN- COUNCIL

---

Entitled

A King's Order-In-Council to amend the Swaziland Development and Savings Bank Order, 1973.

ENACTED by the King in collaboration with the Council.

*Short title.*

1. This Order may be cited as the Swaziland Development and Savings Bank (Amendment) Order, 1993.

*Amendment of Section 4.*

2. Section 4 of the Order is amended as follows -

- (a) In sub-section (1) by replacing the words "five million rand (R5 000 000)" with the words "ten million Emalangeni (E10,000,000)."
- (b) In sub-section (1) in the second proviso by replacing the word "three" with the word "four" in the sentence "at any time exceeding three times."

*Amendment of Section 5.*

3. Section 5 of the Order is amended by inserting after paragraph (O) the following new paragraph:  
"(P) Achieve an excess of revenue over expenditure such excess to be used for the future development of the Bank or for such other purposes as may be determined by the Minister."

*Amendment of Section 6.*

4. Section 6 is amended as follows -

- (a) by deleting sub-section (1) and replacing it with the following:

"(1) The Bank shall have a Board of Directors consisting of a Chairman, the Principal Secretary in the Ministry of Finance, the Managing Director of the Bank and six other members appointed by the Minister."

(b) by deleting the proviso to sub-section (1) and replacing it with the following:

"Provided that five of the Members appointed by the Minister shall not be public servants, and that the members shall be appointed on the basis of their skill in banking, financial, commercial and agricultural matters."

*Amendment of Section 8.*

5. Section 8 of the Order is amended in sub-section (1) by deleting the proviso to that sub-section.

*Amendment of Section 9.*

6. Section 9 of the Order is amended by deleting sub-section (3) and replacing it with the following

"(3) A sub-committee shall consist of the Chairman, or an alternate member selected by the Board, and at least two other members of the Board."

*Amendment of Section 10.*

7. Section 10 of the Order is amended as follows -

(a) by replacing sub-section (1) with the following sub-section:

"(1) The Minister in consultation with the Cabinet Standing Committee and the Board of Directors, shall appoint a Managing Director of the Bank on such terms and conditions as may be agreed upon, but subject to this Order."

(b) by replacing the words "General Manager" occurring in sub-section (2) with the words "Managing Director."

(c) by replacing sub-section (3) with the following sub-section:

"(3) In the event of the Managing Director being absent on leave or on account of his incapacity, he shall appoint one of his Deputies to act as Managing Director."
