THE UMBUTFO SWAZILAND DEFENCE FORCE (REMUNERATION) REGULATIONS,
1993

(Under Section 34)

In exercise of the powers vested in me by Section 34 of the Umbutfo Swaziland Defence Force Order 1977, I MSWATI III, KING OF SWAZILAND, on the advice of the Army Commander, hereby make the following Regulations:-

Citation and Commencement.

1. These regulations may be cited as the Umbutfo Swaziland Defence Force (Remuneration) Regulations 1993 and shall be deemed to have come into force on the 1st April, 1993.

Remuneration of Members of the Defence Force

2. The remuneration of the members of the Umbutfo Swaziland Defence Force shall be as set out in the schedule hereto.

Revocation of Legal Notice No. 124 of 1992.

3. The Umbutfo Swaziland Defence Force (Remuneration) Regulation 1992 are hereby revoked.
