(Under Section 3)

In exercise of the powers conferred by section 3 of the Commission of Enquiry Act 1963, I  
SISHAYI SIMON NXUMALO Deputy Prime Minister hereby issues the following Notice -

*Citation.*

1. This notice may be cited as the Commission of Enquiry Into Certain Projects under the  
Tinkhundla Office Notice, 1994.

*Establishment of Commission.*

2. (1) There is hereby established a commission, to be known as the Commission of Enquiry  
into Certain Projects under the Tinkhundla Office (hereinafter referred to as "the Commission").

(2) The Commission shall be composed of the following members

*Functions and Terms of Reference of Commissions.*

3. The Commission shall examine and inquire into the circumstances leading to the  
observations of the Auditor General in his report of 31st March, 1993 in relation to the  
Tinkhundla office and in particular shall -

(a) in relation to the Women in Development Project -

- (i) investigate whether or not the Project kept proper books of account;
- (ii) investigate the reasons leading to the failure of accounting for the sum of  
E44,552-50 by the Project;
- (iii) investigate who was authorised to be signatory of all cheques relating to  
expenditure by the Project in the UNICEF Account;
- (iv) make any recommendations as to how the donor funds relating to the Project  
can be better accounted for and any other recommendation they deem  
necessary.

(b) in relation to Self Help Projects -

- (i) investigate whether all monies budgeted for these Projects were actually  
spent on them;
- (ii) investigate whether all purchases made in relation to the Projects were  
actually used for such projects.

- (c) in relation to the Elections Fund (Peoples Participation Programme) -
- (i) investigate whether proper accounting procedures were followed when purchasing materials to support the programme;
  - (ii) investigate whether all material purchased in relation to this Programme were used for the Programme;
  - (iii) investigate any possible irregularities in relation to This Programme;
  - (iv) make any recommendations as they deem necessary.
- (d) in relation to the items mentioned in Schedule hereto investigate their disappearance and make any recommendations as they deem necessary.

*Enquiry venue.*

3. The enquiry shall be held at such times as the Commission may determine.

*Enquiry in camera.*

4. Except where the Deputy Prime Minister otherwise directs the enquiry shall be held in camera and the Commission shall take such steps as to preserve the secrecy of the proceedings and recommendations.

*Duration of enquiry.*

5. The Commission shall commence its functions on 9th August, 1994 and shall submit its report by 31st October, 1994 or on such later date as the Deputy Prime Minister may by Notice appoint.
