THE STOCK DISEASE (RABIES NO. 7) REGULATIONS, 1996
(Under Section 3)

In exercise of the powers conferred by Section 3 of the Animal Diseases Act, 1965 the Minister for Agriculture and Cooperatives hereby makes the following Regulations:

Citation and Commencement.

1. These Regulations may be cited as the Stock Disease (Rabies No. 7) Regulations, 1996 and shall be deemed to have come into force on 2 May, 1996.

Declaration of Rabies Guard Areas.

2. The areas specified in the First Schedule are declared to be Rabies Guard Areas.

Isolation and Confinement of Dogs.

3. Every owner of a dog or cat in a guard area shall isolate and confine his dog or cat so as to prevent it from escaping from such guard areas and such confinement and isolation shall remain in force until further notice.

Presentation of Dogs and Cats for Vaccination.

4. A person who owns a dog or cat and lives within the area specified in the first schedule to this Notice shall present his pets for inoculation at the designated vaccination centre and on the time specified in the Second Schedule.

Offence and Penalty.

5. An owner of a dog or cat who fails to comply with Regulation 3 commits an offence and is liable on conviction, to a fine not exceeding E300.00 and in default of payment, to imprisonment for a period not exceeding 3 months.

Destruction of Dogs and Cats in Rabies Guard Areas.

6. A Government Veterinary Officer may destroy a dog or cat in any of the Rabies guard areas if in his opinion, the dog or cat has not been confined so as to prevent it from escaping from such guard areas.

THE CENSUS RULES, 1996
(Under Section 6)

In exercise of the powers conferred by the Census Act, 1904 the Minister for Economic Planning and Development hereby makes the following Rules:

Citation and Application.

1. These Rules may be cited as the Census Rules, 1996 and apply to the census ordered to be taken by Legal Notice No. 69 of 1996.

Taking Census.

2. There shall be a census of all persons who, during the night between the twenty-fifth day of August, 1996 and the twenty-sixth day of August, 1996 either -

- (a) slept at a dwelling in Swaziland; or
- (b) were ordinarily resident there but temporarily resident outside Swaziland.

Functions of census officers

3. In addition to their functions under the Act, the functions of census officers shall be to -

- (a) enumerate provisionally between the 12th day of August, 1996 and the 28th day of August, 1996 at such times and at such places as may be expedient, the persons to be enumerated under Rule 2;
- (b) enumerate on the days and between the hours specified in Legal Notice No. 69 of 1996 the persons to be enumerated under Rule 2.
- (c) ask such questions of any occupier of a dwelling as may be necessary in order to obtain in respect of such occupier and where expedient, in respect of any other person referred to in Rule 5 the particulars required under Rule 4;
- (d) record at the time in questionnaires in the approved form the particulars furnished to them.

Particulars required (Questionnaire).

4. The particulars to be furnished to a census officer are as set out in the questionnaire in the Schedule to be completed on a form approved by the Minister for Economic Planning and Development.

Persons required to give information.

5. A census officer may require a person of the apparent age of twelve years or over to furnish the particulars required.

Duties of person questioned to furnish particular of other persons.

6. A person questioned by a census officer at a dwelling shall give, to the best of his knowledge and belief, if so required by a census officer, the particulars of -

- (a) any person who ordinarily resides in that dwelling and who is likely to be or was absent from Swaziland on the night between the 25th day of August, 1996 and the 26th day of August, 1996;
- (b) any other person who is likely to spend, or spent, that night in the dwelling.

Penalty.

7. A person who, without reasonable excuse -

- (a) fails to furnish any particulars required in accordance with these Rules; or
- (b) gives to a census officer acting in the performance of his functions, information which the person knows to be false or does not believe to be true; or
- (c) wilfully obstructs a census officer in the performance of his functions;

is guilty of an offence and is liable, on conviction to a penalty of a fine not exceeding one hundred emalangenis, or in default of payment, imprisonment for a period not exceeding three months.

LEGAL NOTICE NO. 72 OF 1996

THE CONSOLIDATED MATSAPHA TOWN REGULATIONS, 1970
NOTICE OF DECLARATION OF FORFEITURE
(Under Regulation 13)

1. On the 14th of March 1986 the Government of Swaziland sold Lot No. 467 and Portion 14 of Farm 34, Matsapha Town, to Harman Investments and Trading (Pty) Limited.
2. The said properties were duly transferred to Harman Investments and Trading (Pty) Limited in terms of Crown Grant No. 42/1987 and Crown Grant No. 43/1987.
3. The said sale was subject to the conditions that:
 - "11 (1) Not later than two years after the date of sale there shall be completed upon the plot purchased the erection of a building or buildings in accordance with plans submitted to, and approved by, the local authority.
