STATUTORY CONTRIBUTIONS REGULATIONS, 1996  
(Under Sections 14, 15 & 17)

In exercise of the powers conferred on him by the above-mentioned Order, and after consultation with the Honourable Minister for Finance, the Honourable the Minister for Labour and Public Service is pleased to make the following regulations:-

*Citation and commencement.*

1. These regulations may be cited as the Swaziland National Provident Fund (Statutory Contributions) Regulations, 1996, and shall come into force on 1st January, 1997.

*Wages level for statutory contributions.*

2. Statutory contributions shall be payable by a contributing employer in respect of wages of E400 or less during any calendar month, and wages of eligible employees exceeding E400 during any such month shall be disregarded for the purpose of statutory contributions.

*Statutory contributions.*

3. A contributing employer shall, after every contribution period, pay into the Fund a statutory contribution in respect of each eligible employee employed by him during every such period at the rate prescribed for him in the Schedule hereto.

*Employee's share.*

4. A contributing employer who is required to pay a statutory contribution in respect of an employee may deduct the "employee's share" of such contribution from the wages due from him to that employee at the rate prescribed for him in the Schedule hereto.

*Repeal.*

5. The Statutory Contributions Regulations, 1993, published as Legal Notice No. 132 of 1993, is hereby repealed.



YEAR ENDED 31 MARCH 1996*1. Statement of Accounting Policies.*

The Bank's financial statements are prepared under the historical cost convention. The financial statements have also been prepared to comply with the requirements of the Central Bank of Swaziland Order 1974 as amended, and operative International Accounting Standards in so far as it is considered material and appropriate. The significant accounting policies in the preparation of these financial statements are set out below:

*1.1 Foreign Currencies.*

Foreign currency balances other than Gold, are revalued in accordance with the provisions of Section 35 of the Central Bank of Swaziland Order 1974. Gold is stated at cost. Gains/Losses arising on revaluation are transferred to the revaluation account.

*1.2 Forward Contracts.*

Net Forward Position in Foreign Currencies is revalued in accordance with Section 35 of the Central Bank of Swaziland Order 1974. The unrealised gain or loss is transferred to the revaluation account.

*1.3 Investments.*

Investments are adjusted to take account of discounts earned or premiums paid, over their remaining life, so that book value at maturity equals the redemption value.

*1.4 Fixed Assets.*

All fixed assets are capitalised in the year of acquisition and are depreciated to write off their cost or valuation over their estimated useful lives in equal annual instalments.

*18. Pension Fund*

The pension fund is a non-contributory defined benefit scheme established by the Bank on 1st April 1981. The assets of the fund are independent of the Bank's finances. The fund is financed by contributions from the Bank being charged to income at 15% of gross salaries. Total contributions for the year ended 31st March 1996 amounted to E1 392 020. The fund was actuarially valued as at 1st April 1994 and the actuary's valuation disclosed a deficit of approximately E83 000 at that date. It was recommended that the Bank continue to contribute to the fund at a rate of 12.96% of pensionable salaries. In the actuary's opinion the Fund is making adequate provision to meet its liabilities and on that basis is in a sound financial condition. The next actuarial valuation is due in April 1997.

YEAR ENDED 31 MARCH 1996 (cont.)*19. Meridien BIAO Bank Swaziland Limited*

Meridien BIAO Bank Swaziland Limited was seized by Central Bank of Swaziland on 6 March 1995. In terms of an agreement dated 12 April 1995 the shares of Meridien BIAO Bank Swaziland Limited were acquired by First National Bank Holdings Limited. No significant costs were incurred by Central Bank of Swaziland as a result of the seizure.

A further term of the agreement required Central Bank of Swaziland to advance to First National Bank of Swaziland Limited an amount of E30m as at 13 April 1995 representing the preliminary assessment of the losses of Meridien BIAO Bank Swaziland Limited at the date of seizure. The losses are reassessed on a 6 monthly basis by KPMG who act as auditors to First National Bank. In October 1995 the losses were reassessed at E36 759 243 and accordingly a further amount of E6 759 243 was advanced to First National Bank of Swaziland Limited by Central Bank of Swaziland. The total advance is secured by a Loan Stock Note dated 19 April 1996, from Swaziland Government which is subject to review after the determination of the deficit by First National Bank of Swaziland Limited until 30 September 2001 at which stage Central Bank of Swaziland will reclaim the amount advanced from Swaziland Government in terms of the Loan Stock Note.

*20. Swaziland Development and Savings Bank*

On 2 May 1995 the Central Bank of Swaziland was appointed by the Ministry of Finance to manage the affairs of the Swaziland Development and Savings Bank. The Central Bank of Swaziland's responsibility was of an administrative nature and there was no financial cost to the bank. This arrangement terminated at 31 March 1996 when AMSCO was appointed to perform the management function of Swaziland Development and Savings Bank.
