THE ESTABLISHMENT OF THE PARLIAMENT OF SWAZILAND ORDER, 1992

(Order No. 1 of 1992)

ASSIGNMENT OF RESPONSIBILITIES TO MINISTERS NOTICE, 1996

(Under Section 53)

In exercise of the powers vested in me by section 53 of the Establishment of Parliament of Swaziland Order, 1992, and after consultation with the Prime Minister, I MSWATI III, KING OF SWAZILAND hereby issue the following Notice -

Citation.

1. This Notice may be cited as the Assignment of Responsibilities to Minister Notice, 1996.

Assignment of Ministerial Responsibilities.

2. The responsibilities in the Schedule hereto are hereby assigned to the respective Ministers as set out in the Schedule and where there is a conflict between responsibilities of Ministers under this Notice or where this Notice does not specify the Minister in relation to a responsibility not otherwise specified therein, the Prime Minister may give directive in writing as to which Minister shall be vested with such responsibility.

3. The Assignment of Responsibilities to Ministers Notice No. 44 of 1996 is hereby revoked.
