**NON-BAILABLE OFFENCES ORDER, 1993**  
**(Order No. 14 of 1993)****NON-BAILABLE OFFENCES (AMENDMENT OF SCHEDULE)**  
**NOTICE, 1997**  
**(Under Section 3)**

In exercise of the powers conferred by section 3 of the Non-Bailable Offences Order, 1993 the Minister for Justice and Constitutional Affairs hereby issues the following Notice -

**Citation**

1. This Notice may be cited as the Non-Bailable Offences (Amendment of Schedule) Notice, 1997.

**Amendment of Schedule**

2. The Schedule to the Non-Bailable Order is hereby amended by adding the following -

“11. A contravention of Section 4, 10, 11, 12, 13, 16 and 17 of the Public Order Act No.17 of 1963.”

**THE DESIGNATION OF THE SWAZILAND FEDERATION OF TRADE  
UNIONS MASS STAY AWAY AS A BOYCOTT, NOTICE, 1997**

**(UNDER SECTION 13)**

In exercise of the powers conferred upon me by section 13 of the Public Order Act, 1963, I **BARNABAS SIBUSISO DLAMINI PRIME MINISTER OF THE KINGDOM OF SWAZILAND** hereby designate the mass stay away called by the Swaziland Federation of Trade Unions to start on the 3rd February 1997 or any date thereafter, to be a Boycott as it is likely to have the effect of –

- (a) endangering the economic life of Swaziland.
- (b) endangering public Order; and
- (c) bringing into hatred or contempt, exciting disaffection against or undermining the lawful authority of the Swaziland Government;

Further, in exercise of the powers conferred upon me under the said section 13, I hereby specify in relation to the designated Boycott the following actions to be likely to further such Boycott -

- (a) the unlawful interference with members of the public in their normal daily activities;
- (b) the unlawful interference with and disruption of public transport operations;
- (c) the unlawful withdrawal of employees services from their employers including essential services as defined under the Industrial Relations Act, 1996 or any successor thereto;
- (d) the unlawful interference with the life and property of members of the public and the state;

- (e) the unlawful interference and disruption of the educational system;
- (f) the unlawful interference with and disruption of normal business operations;
- (g) the unlawful interference with any person doing any act which may lawfully be done or any person omitting to do anything which may lawfully be omitted to be done.

This Notice shall operate with immediate effect until further notice.
