This will improve transparency and avoid the possibility of preparing budget estimates that assume that the Council pays rates like any property owner. An alternative to have this last category would be for the Council to provide in its budget and pay rates like everybody.

This structure facilitates the setting of rates which can shift the burden to owners of types of property. This structure is also easy to administer since the valuation roll differentiate properties mainly on use types. Any other differential rate structure that is not based on land use would be extremely difficult if not impossible to apply.

FINANCE AND AUDIT ACT, 1967

(Act No. 18 of 1967)

THE ADMINISTRATION OF THE VETERAN SOLDIERS DISABLED PERSONS AND
DEPENDANTS PENSION SPECIAL FUND (AMENDMENT) REGULATIONS, 1997

(Under Section 12 (4))

In exercise of the powers vested by section 12 (4) of the Finance and Audit Act, 1967, the Minister for Finance issues the following Regulations -

Citation.

1. These Regulations may be cited as the Administration of the Veteran Soldiers, Disabled Soldiers and Dependants Pensions Special Fund (Amendment) Regulations, 1997, and shall be read as one with the Veteran Soldiers, Disabled Soldiers, and Dependants Pensions Special Fund Regulations, 1996 (hereinafter referred to as the "Principal Regulations")

Amendment of Regulation 2.

2. Regulation 2 of the Principal Regulations is amended by inserting the following definition between the first and second sentences -

"dependant" means the spouse of the veteran or disabled soldier."
