THE UMBUTFO SWAZILAND DEFENCE FORCE ORDER, 1977 (Order No. 10 of 1977)

THE UMBUTFO SWAZILAND DEFENCE FORCE (REMUNERATION) REGULATIONS 1997 (Under Section 34)

In exercise of the powers vested in me by section 34 of the Umbutfo Swaziland Defence Force Order, 1977, I, MSWATI III, KING OF SWAZILAND, on the advice of the Army Commander, hereby make the following Regulations -

Citation and commencement.

1. These Regulations may be cited as the Umbutfo Swaziland Defence Force (Remuneration) Regulations, 1997 and shall be deemed to have come into force, in respect of the 1.1%, on the 1st April, 1996 and, in respect of the 8% on the 1st April, 1997.

Remuneration of members of the Defence Force.

2. The remuneration of the members of the Umbutfo Swaziland Defence Force shall be as set out in the Schedule hereto.

Revocation of Legal Notice No. 107 of 1996.

3. The Umbutfo Swaziland Defence Force (Remuneration) Regulations, 1996 are hereby revoked.
