 - a) interdicting and restraining the said Swaziland Federation of Trade Unions and its members from taking a strike action (or "Rolling Mass Action") on 13 October 1997 or on any other date before or immediately after that date.
 - b) interdicting and restraining the said Swaziland Federation of Trade Unions through its office-bearers and other of its members from inciting, organising, instigating, or calling for the taking of the strike action (or "Rolling Mass Action") referred to in para. 2 hereof.
 - c) declaring the threatened strike action (or Rolling Mass Action") referred to in para. 2 hereof to be unlawful and/or to be a threat to the national interest and/or to be capable of harming the national interest.
 - d) granting the applicant further or alternative relief.
- 3. It is further ordered that this Rule Nisi shall operate forthwith as an interim interdict in terms of paras. 2 (a), 2 (b) and 2 (c) hereof.
