Short title.

1. This Act may be cited as the Loan (Rehabilitation of the Goba-Matsapha Railway Project) Act, 1997.

Interpretation.

2. In this Act, unless the context otherwise requires -

"Agreement" means the Agreement referred to in section 3 and includes any document related thereto;

"Borrower" means the Government of the Kingdom of Swaziland;

"Lender" means the Government of the Italian Republic.

"Loan" means the loan raised by the Minister in section 3.

"Minister" means the Minister for Finance.

Authority to raise Loan.

3. The Minister is hereby authorised to enter into an Agreement with the Lender for the purpose of raising a Loan not exceeding the equivalent of 20 (twenty) billion Italian Lira, approximately 52 (fifty-two) million Emalangeni, upon terms and conditions specified in this Act and upon such other terms and conditions as the Government may consider appropriate.

Loan charges and repayments.

4. (1) The Loan shall be payable in 36 (thirty six) half-yearly consecutive equal principal instalments after a grace period of ten years and six months from the date of effectiveness of the Financial Agreement.

(2) The Borrower shall pay an interest rate of 1 (one) per cent per annum, calculated on the balance disbursed and outstanding, payable in semi-annual instalments, starting from the date of the first drawdown of the Loan.

Charging of Loan.

5. (1) The loan shall be charged upon the Consolidated Fund and Assets of the Borrower who will, in turn, pass the charges on to the Swaziland Railways on terms agreed between the two parties.

(2) The Swaziland Railways shall be liable to pay to the Borrower the charges and all other monies agreed upon and in accordance to the terms referred to in subsection (1) and to such other agreement, if any, or law applicable.

Application of Loan.

6. The proceeds of the Loan shall be used solely to finance the contracts that shall be stipulated by and between the Swaziland Railways and the Italian Companies for the supply of the components for the Rehabilitation of the Goba-Matsapha Railway Project.

Exemption.

7. The Italian goods and services supplied under section 6 shall be exempt in the Kingdom of Swaziland from taxes and customs duties.
