#### LEGAL NOTICE NO. 3 OF 1998

### ANIMAL DISEASE ACT, 1965 (Act No. 7 of 1965)

## THE STOCK DISEASE (RABIES NO. 1) REGULATIONS, 1998 (Under Section 3)

In exercise of the powers conferred by Section 3 of the Animal Diseases Act, 1965 the Minister for Agriculture and Cooperatives hereby makes the following Regulations:

Citation and Commencement.

1. These Regulations may be cited as the Stock Disease (Rabies No. 1) Regulations, 1998 and shall be deemed to have come into force on 16th January, 1998.

Declaration of Rabies Guard Areas:

2. The areas specified in the First Schedule are declared to be Rabies Guard Areas.

Isolation and Confinement of Dogs.

3. Every owner of a dog or cat in a guard area shall isolate and confine his dog or cat so as to prevent it from escaping from such guard areas and such confinement and isolation shall remain in force until further notice.

Presentation of Dogs and Cats for Vaccination.

4. A person who owns a dog or cat and lives within the area specified in the first schedule to this Notice shall present his pets for inoculation at the designated vaccination centre and on the time specified in the Second Schedule.

Offence and Penalty.

5. An owner of a dog or cat who fails to comply with Regulation 3 or 4 commits an offence and is liable on conviction, to a fine not exceeding E300.00 and in default of payment, to imprisonment for a period not exceeding 3 months.

Destruction of Dogs and Cats in Rabies Guard Areas.

- 6. (1) A Government Veterinary Officer may destroy a dog or cat in any of the Rabies guard areas if in his opinion, the dog or cat has not been confined so as to prevent it from escaping from such guard areas.
- (2) In pursuance of subregulation (1) a Government Veterinary Officer may ask for the assistance of the Royal Swaziland Police in carrying out the provision of that sub-regulation.

#### LEGAL NOTICE NO. 4 OF 1998

#### ANIMAL DISEASE ACT, 1965 (Act No. 7 of 1965)

# THE STOCK DISEASES (FOOT AND MOUTH DISEASE NO. 2) REGULATIONS, 1998 (Under Section 3 of the Act)

In exercise of the powers conferred by Section 3 of the Animal Diseases Act, 1965 the Minister for Agriculture and Cooperatives hereby makes the following Regulations:

Citation and Commencement.

1. These Regulations may be cited as the Stock Disease (Foot and Mouth Disease No. 2) Regulations, 1998 and shall be deemed to have come into force on 15th December, 1997.

Declaration of Foot and Mouth Disease Guard Areas.

2. The areas falling under the Dip Tank Areas specified in the Schedule to this Notice are hereby declared Foot and Mouth Disease Guard Areas.

Prohibition of Movement of animals and Animal Products.

3. The movement of animals and animal products out of the guard areas is hereby prohibited. Movement of such into the guard areas other that in accordance with the written permission of the Director of Veterinary Services or his appointed representatives is prohibited.

Restriction of Movement of Persons, Vehicles and Containers.

4. The movement of persons in the guard areas other than those involved in official duties related to the disease is highly restricted. Vehicles, containers and persons moving in and out of the guard areas may be subjected to the necessary searches and sanitary measures prescribed under these regulations.

Presentation of Susceptible Animals for Examination and testing.

5. Owners of all susceptible animals in the guard areas shall present them to the diptank areas specified in the Schedule to this Notice for examination and testing as is necessary and are called upon to do so.

Destruction of Infected Animals.

6. All susceptible animals found to be infected or reacting positively to the disease antigen in the guard areas shall be destroyed under veterinary supervision.

Offences and Penalties.

7. Any person who contravenes the provisions or fails to comply with the requirements of the regulation prescribed under Section 3 commits an offence and shall, on conviction be liable to such penalties as are prescribed with these regulations. No such penalty shall exceed Six Hundred Emalangeni (600) or imprisonment for two (2) years or both.

Revocation of Legal Notice No 174 of 1997.

8. Legal Notice No. 174 of 1997, The Stock Diseases (Foot and Mouth Disease No. 1) Regulations 1997, is hereby revoked.
