Establishment and Composition of the Team.

2. (1) There is hereby established a Task Team to be known as the Protea Pigg's Peak Hotel Restructuring Task Team hereafter in this Notice referred to as "the Team" and shall consist of the following persons as its members:

Functions of the Team.

3. The functions of the Team are to:

- (a) review the strategic analysis report with a view to mapping out an implementation plan;
- (b) supervise consultants appointed and funded by the Ministry of Tourism, Environment and Communications to assist with the technical aspects of leasing;
- (c) use other consultants and the present hotel operator, at the hotel's cost to resolve any outstanding legal and financial matters that may impede the leasing of the hotel;
- (d) co-ordinate communication between Ministries that can contribute to the execution of this task;
- (e) advise the Ministry of any other related matters affecting the successful leasing of the hotel;
- (f) undertake all the necessary steps to achieve the leasing of the Pigg's Peak hotel in conformity with the approval of SCOPE.

Allowances and Reimbursements.

4. The members of the Team shall be entitled to such allowances as the Minister may determine.

Report.

- 5. (1) The Team shall present its report to the Minister on or before the 31st July, 2000.
- (2) Notwithstanding subsection (1), the Minister may extend the time within which the report may be submitted.

Meetings

6. The Team shall meet at such place and time as the Chairman of the Team may determine.
