**THE MAXIMUM WHOLESALE AND RETAIL PRICES OF PETROLEUM
 PRODUCTS NOTICE, 2000**

In exercise of the powers conferred by section 5 and 10 of the Prices Control Order, 1973 the Price Controller issues the following Notice.

Citation and Commencement

1. This Notice may be cited as the Maximum Wholesale and Retail Prices of Petroleum Products Notice, 2000 and shall be deemed to have come into force at midnight on Wednesday the 5th of July 2000.

Maximum Prices and Petroleum Products

2. (1) Subject to section 2 (2), the maximum wholesale and retail prices of petroleum products shall be as set out in the Schedule to this Notice.

(2) Maximum wholesale and retail prices of petroleum products as set out in the Schedule shall be subject to the condition that no oil company shall grant or allow a rebate or discount to any customer without first obtaining the consent of the Price Controller.

THE PUBLIC SERVICE PENSION ORDER, 1993
(Order No. 13 of 1993)

THE PUBLIC SERVICE PENSIONS FUND (AMENDMENT) REGULATIONS, 2000
(Under Section 9)

In exercise of the powers conferred by Section 9 of the Public Service Pension Order, 1993, The Minister for Finance hereby makes the following Regulations -

Citation and Commencement

These Regulations may be cited as the Public Service Pension Fund (Amendment) Regulations, 2000 and shall be read as one with the Public Service Pension Fund Regulations, 1993 (hereinafter referred to as the Principal Regulations) and shall be deemed to have come into force on the 1st June, 2000.

Amendment of Regulation 16

2. Regulation 16 of the Principal Regulations is amended by replacing it with the following -

"16. A member of the Fund who dies while still being a member shall be entitled to a death benefit equal to two years salary based upon that member's pay scale as at the day of the member's death, and such benefit shall be paid to the member's estate."
