THE INDUSTRIAL RELATIONS ACT, 2000 (Act No. 1 of 2000)

APPOINTMENT OF MEMBERS OF THE LABOUR ADVISORY BOARD NOTICE, 2000

(Under section 23)

In exercise of the powers conferred by section 23 of the Industrial Relations Act, 2000 the Minister for Enterprise and Employment makes the following Notice -

Citation and commencement.

1. This Notice may be cited as the Appointment of Members of the Labour Advisory Board Notice, 2000 and shall come into force on the 25th August, 2000.

Establishment and Composition of the Board.

2. The following persons are hereby appointed to be members of the Labour Advisory Board for a period not exceeding one year, effective from 25th August, 2000 to 24th August, 2001.

3. The Commissioner of Labour shall be the chairperson and in the absence of the Commissioner of Labour, the Deputy Commissioner of Labour or one of the Vice Chairpersons shall act as Chairperson.
