LEGAL NOTICE NO. 156 OF 2000

ANIMAL DISEASE ACT, 1965 (Act No. 7 of 1965)

THE STOCK DISEASES (FOOT AND MOUTH DISEASE NO. 1) REGULATIONS, 2000 (Under Section 3)

In exercise of the powers conferred by Section 3 of the Animal Diseases Act 1965, the Minister for Agriculture and Cooperatives hereby makes the following Regulations:

Citation and Commencement

1. These Regulations may be cited as the Stock Diseases (Foot and Mouth Disease No. 1) Regulations 2000 and shall be deemed to have come into force on 01 December 2000.

Declaration of Foot and Mouth Disease Guard Areas

2. The areas falling under the diptank areas specified in the First and Second Schedules to this Notice are hereby declared Foot and Mouth Disease Guard Areas.

Prohibition of Movement of Animals and Animal Products

3. The movement of animals and animal products out of the Guard Areas is hereby prohibited and any movement of such into the Guard Areas, other than in accordance with the written permission of the Director of Veterinary and Livestock Services or his appointed representatives, is prohibited.

Movement of Persons, Vehicles and Containers

4. Vehicles, containers and people moving in and out of the Guard Areas may be subjected to the necessary searches and sanitary measures prescribed under these regulations.

Presentation of Susceptible Animals for Examination and Testing

5. Owners of all animals in the Guard Areas shall present the animals to the diptank areas specified in Schedule 1 and 2 for examination and testing as is necessary and are called upon to do so.

Destruction of Infected Animals

6. All animals found to be infected or reacting positive to the disease agent, in the Guard Areas, shall be destroyed under veterinary supervision.

Offences and Penalties

7. Any person who contravenes the provisions or fails to comply with the requirements of the regulations commits an offence and shall be liable, on conviction, to a fine not exceeding six hundred Emalangeni or imprisonment to a term not exceeding two years or to both.
