CONTRIBUTIONS) REGULATIONS, 2001
(Under Sections 14, 15 and 17)

In exercise of the powers conferred on him by sections 14, 15 and 17 of the Swaziland National Provident Fund Order, 1974, the Honourable Minister for Finance, after consultation with the Honourable Minister for Economic Planning hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Swaziland National Provident Fund (Statutory Contributions) Regulations, 2001, and shall come into force of the 1st day of January, 2002.

Wages level for statutory contributions

2. Statutory Contributions shall be payable by a contributing employer in respect of wages of six hundred Emalangeni (E600) or less during any calendar month, and wages of eligible employees in excess of six hundred Emalangeni (E600) during any such month shall be disregarded for the purpose of statutory contributions.

Statutory contributions

3. A contributing employer shall, after every contribution period, pay into the Fund a statutory contribution in respect of each eligible employee employed by that employer during such period at the rate prescribed for that employer in the Schedule hereto.

THE STOCK DISEASES (RABIES NO. 6) REGULATIONS, 2001
(Under Section 3)

In exercise of the powers conferred by Section 3 of the Animal Diseases Act, 1965 the Minister for Agriculture and Cooperatives hereby makes the following Regulations:

Citation and Commencement:

1. These Regulations may be cited as the Stock Disease (Rabies No. 6) Regulations, 2001 and shall be deemed to have come into force on 26th September, 2001.

Declaration of Rabies Guard Areas:

2. The areas specified in the First Schedule are declared to be Rabies Guard Areas.

Isolation and Confinement of Dogs:

3. Every owner of a dog or cat in a guard area shall isolate and confine his dog or cat so as to prevent it from escaping from such guard areas and such confinement and isolation shall remain in force until further notice.

Presentation of Dogs and Cats for Vaccination:

4. A person who owns a dog or cat and lives within the area specified in the schedule to this Notice shall present his pets for inoculation at the designated vaccination centre and on the time specified in the Second Schedule.

Offence and Penalty:

5. An owner of a dog or cat who fails to comply with regulation 3 and 4 commits an offence and is liable on conviction, to a fine not exceeding E300-00 and in default of payment, to imprisonment for a period not exceeding 3 months.

Destruction of Dogs and Cats in Rabies Guard Areas:

6. (1) A Government Veterinary Officer may destroy a dog or cat in any of the Rabies guard areas if in his opinion, the dog or cat has not been confined so as to prevent it from escaping from such guard areas.

(2) In pursuance of sub-regulation (1) a Government Veterinary Officer may ask for the assistance of the Royal Swaziland Police in carrying out the provision of that sub-regulation.
