SPEED LIMITS ON PUBLIC ROADS NOTICE, 2002 (Under section 81)

In exercise of the powers conferred by section 81 of the Road Traffic Act, 1965, the Minister for Public Works and Transport makes the following Notice.

Citation and commencement

1) This Notice may be cited as the Speed Limits on Public Roads Notice, 2002 and shall come into force on publication on the Gazette.

The Speed limits for the MR3 (East bound lane)

2) The speed limit for the MR3, east bound lane (Mbabane to Manzini direction) shall be as follows -

- (a) Mountain View traffic lights to Swazi Inn - 60km/hr;
- (b) Swazi Inn to Bahai - 80km/hr;
- (c) Bahai to Ezulwini (MR103 off-ramp) - 100km/hr;
- (d) Ezulwini (MR103 off-ramp) to a point, which is 200 metres to or from Luntsantsama Bridge - 120km/hr;
- (e) From a point which is 200 metres to or from Luntsantsama Bridge to a point which is 200 metres to or from Matsapha traffic circle - 100km/hr;
- (f) From a point which is 200 metres from or to Matsapha traffic circle to Matsapha traffic circle - 60km/hr;
- (g) Matsapha traffic circle to a point which is 200 metres to or from KaKhoza traffic lights - 100km/hr;
- (h) From a point which is 200 metres to or from KaKhoza traffic lights to KaKhoza traffic lights - 60km/hr.

Speed limit for MR3 (Westbound lane)

3. The speed limit for the MR3, westbound lane shall be as follows -

- (a) KaKhoza traffic lights to a point which is 200 metres to or from Matsapha traffic circle - 100km/hr;
- (b) From a point which is 200 metres to or from Matsapha traffic circle to the Matsapha traffic circle - 100km/hr;
- (c) Matsapha traffic circle to a point 100 metres after Luntsantsama Bridge - 100km/hr;

- (d) From a point 100 metres after or from Luntsantsama Bridge to Bahai - 120km/hr;
- (e) Bahai to a point 200 metres from or to Mountain View traffic lights - 80km/hr;
- (f) From a point 200 metres from or to Mountain View traffic lights to the traffic lights - 60km/hr;
