### THE COMMISSIONS OF ENQUIRY ACT, 1963 (Act No. 35 of 1963)

#### THE COMMISSION OF ENQUIRY INTO THE SWAZILAND ELECTRICITY BOARD (SEB) (EXTENSION OF TIME) NOTICE 2002 (Under Section 3 and 4)

In exercise of the powers conferred by sections 3 and 4 of the Commissions of Enquiry Act, 1963 the Minister for Natural Resources and Energy hereby issues the following Notice:-

#### *Citation and commencement*

1. This Notice may be cited as the Commission of Enquiry into the Swaziland Electricity Board (SEB) (Extension of Time) Notice, 2002 and shall be deemed to have come into force on the 6<sup>th</sup> day of March 2002.
