## LEGAL NOTICE NO. 91 OF 2002

### THE FINANCE AND AUDIT ACT, 1967 (Act No. 18 of 1967)

#### THE APPOINTMENT OF THE BOARD OF MANAGEMENT FOR THE CENTRAL TRANSPORT ADMINISTRATION NOTICE, 2002 (Under Section 12 (4))

In exercise of the powers conferred by section 12 of The Finance and Audit Act, 1963 the Minister for Public Works and Transport makes the following Notice.

#### *Citation and Commencement*

1. This Notice may be cited as The Appointment of The Board of Management for The Central Transport Administration Notice, 2002 and shall be deemed to have come into force on 28 June 2002.

#### *Appointment of the Board Members*

2. The Board of Management for the Central Transport Administration shall be composed of the following persons -

Mr. Gerhard Mdziniso - Chairperson

Mr. Elyan Masuku - Deputy Chairperson

Ms. Pholile Dlamini - Member

Mr. Vusi Twala - Member

Principal Secretary - Ministry of Works and Transport/representative

Principal Secretary - Ministry of Finance/representative - Member

General Transport manager/representative - Secretary

#### *Functions of the Board*

3. The Board shall -

- (a) implement the Special Fund Regulations of 1975;
- (b) Establish the special fund;
- (c) establish a trading account to be fully and exclusively operated by the CTA Management under the supervision of the Board;
- (d) phase out the account, which is presently at the Ministry of Finance;
- (e) establish effective cost recovery systems and procedures in order to ensure that ministries pay CTA for services rendered and for goods supplied;

- (f) to prepare a budget for Cabinet's consideration and approval;
- (g) to engage external expertise if necessary; and
- (h) to do any other thing and/or set up any other structures and procedures that may be necessary to enable implementation of the law as stated above.

***Quorum***

- 4. Three members of the Board including the Chairman shall constitute a quorum.

***Duration***

- 5. The Board of management shall serve for a period of 2 (two) years.

***Allowances***

- 6. The members of the Board shall be paid such statutory allowances as are payable to other Boards according to Government scale.
