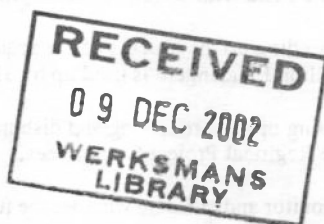

## LEGAL NOTICE NO. 98 OF 2002

### THE COMMISSIONS OF ENQUIRY ACT, 1963 (Act No. 35 of 1963)

#### THE ESTABLISHMENT OF THE REGIONAL DEVELOPMENT FUND TASK FORCE NOTICE, 2002 (Under Section 3 of the Act)

In exercise of powers conferred by section 3 of the Commissions of Enquiry Act, 1963, the Minister for Finance issues the following Notice.

#### *Citation and Commencement*

1. This Notice may be cited as the Establishment of the Regional Development Fund Task Force Notice, 2002, and shall be deemed to have come into force on 1 November 2001.

#### *Interpretations*

2. In this Notice, unless the context otherwise requires-

"the Fund" means the Regional Development Fund under Legal Notice No. 48 of 2000;

"Minister" means the Minister for Finance;

"Regional Project Committees" means committees made up of Members of Parliament and chiefs in each of the regions which are responsible for considering and approving projects submitted to them;

#### *Establishment of the Regional Development Fund Task Force*

3. There is hereby established a Task Force to be known as the Regional Development Fund Task Force (hereinafter referred to as "the Task Force") to operate for a period not exceeding four (4) months from commencement date.

#### *Objects and Purposes of the Task Force*

4. The objects and purposes of the Task Force shall be-
  - (a) to investigate the operations of the Fund with a view to identifying problem areas;
  - (b) to make recommendations for speeding up the process of the acquisition of the funds to ensure that at least thirty (30) million Emalangeni is used up by 31 December 2001;
  - (c) to implement measures for speeding up the processing and disbursement of funds for projects already approved by the Regional Project Committees;
  - (d) to set up mechanisms that will monitor and evaluate whether the funded projects do fulfill the objectives of the fund;

- (e) to make recommendations on the criteria to be used by the Regional Project Committees in approving applications by associations;
- (f) to make recommendations on the structure of the management of the Fund taking into consideration the need for the decentralization of the operations of the Fund;
- (g) to make any other recommendation as may be deemed necessary to facilitate quick and smooth processing of applications for funding; and
- (h) to prepare and submit a report on the above.

***Composition of the Task Team***

5. The Task Team shall be made up of the following members-

- (a) Mr Sandile Ceko - Chairman
- (b) Mr Mbuso Dlamini - Secretary
- (c) Mr Phuhlahphi Dlamini - member
- (d) Mr. Philip K. Zwane - member
- (e) Mr. T.T. Vilane - member
- (f) Mrs Christabel J. Motsa - member
- (g) Mr. Paul S. Dlamini - member
- (h) Mr. Sipho Vilakati - member
- (i) Mr. Elliot Sihlongonyane - member

***Working and Reporting Procedure for the Task Force***

6. In carrying out its assignment, the Task Team shall be assisted by a secretariat and shall work closely with the Deputy Prime Minister's Office and shall report to Cabinet on a regular basis through the Minister of Finance.

***Remuneration of Members of the Task Team***

7. The Task Team shall be paid sitting allowances in accordance with laid government regulations and the secretariat shall be paid a half rate.
